I. Call to Order

Announcement by the president as to the presence of a quorum, that the meeting has been duly called, and that the notice of the meeting has been posted in the manner prescribed by law.

Patrons may only be recognized when Public Participation is an agenda item, and only after having duly registered with the meeting's recording secretary.

II. Closed Session for the purposes permitted as authorized by the Texas Open Meetings Act, Texas Government Code Section:

A. Personnel Matters: Pursuant to Section 551.071 of the Texas Education Code

1. Consultation with School District's attorney on a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with the Texas Open Meetings Act specifically including the legal issues related to the Superintendent's recommendation that the term contracts of Barbara Scott George and Larry Allen be proposed for nonrenewal.

B. Personnel Matters: Pursuant to Section 551.074 of the Texas Government Code

1. Discuss Superintendent's recommendation to propose the nonrenewal of Barbara Scott George's term contract
2. Discuss Superintendent's recommendation to propose the nonrenewal of Larry Allen's term contract
3. Discuss proposed Chapter 21 contracts for teachers for the 2016-2017 school year
4. Discuss the employment of new professional employee(s) for the remainder of the 2015-2016 school year
5. Discuss assignments, re-assignments and duties of at-will and professional employees

B. Discuss and take action on the Superintendent's recommendation that the term contract of Larry Allen be proposed for nonrenewal.
