Student Dress Code

A motion was made by Shirley Price and seconded by Edward Wilson to approve the following change to the dress code for Hitchcock High School: Athletic pants/shorts are allowed and must have a drawstring and pockets and must be worn with a spirit shirt.

Members opposed: Monica Cantrell and Tony Combs  
Members abstained: Tom Ivey and Dianne James

Motion carried with a majority in favor.

A motion was made by Tom Ivey and seconded by Ted Robinson to approve the following change to the dress code for Hitchcock High School: Shoes that are non-plastic are permitted. Slides are permitted only if worn with socks. Shower shoes are not permitted.

Members in favor: Dianne James, Tom Ivey, Shirley Price, Edward Wilson, and Ted Robinson

Members opposed: Monica Cantrell and Tony Combs

Motion carried with a majority in favor.

A motion was made by Tom Ivey and seconded by Monica Cantrell to approve the following change to the dress code for Hitchcock High School: Pants with holes are permitted and shall have no skin or flesh colored fabric (any other color is appropriate) showing through above the knees.

Motion carried with all in favor.

A motion was made by Monica Cantrell and seconded by Tom Ivey to approve the following change to the dress code for Hitchcock High School: Earrings are acceptable for students. However, students shall not have more than two (2) earrings per ear. Students are not permitted to wear other non-traditional piercings, for example, nose, lip, tongue, eyebrow, body rings, gauges, or spikes.

Motion carried with all in favor.
