Discussion

HB3678: Student Religious Anti-Discrimination Act

The 80th Legislature passed a bill into law calling for a limited forum at student related events. Before an event, a student in a leadership position as a junior or a senior may have access to the public address system to speak his/hr religious views without penalty or consequences or censorship. Religious views may be expressed in homework or other assignments without penalty.

Because there is no penalty for the district, our attorney is recommending that, we, as a district, not accept a policy as stated by law by the 1st day of school. Stephen Dubner is saying that the ACLU is probably waiting until the 1st day of school to file suit against the state and districts for such action. It is the administration's recommendation to table any action and watch the developments on this and gradually formulate our policy after having more time to think about this issue.
