Goal #1 - Curriculum & Instruction

Identify areas of concentration to improve curriculum and instruction. Oversee upgrades and revisions to curriculum and instruction with a primary focus on K-8 English Language Arts (ELA) and K-12 math curriculum and resources.

Objectives

- 1. Complete a five-year curriculum cycle plan, which includes monthly timelines.
- 2. Provide detailed timeline, research, staff/student/parent feedback, and recommended changes based on curriculum resources for K-8 ELA and Grades 5-12 Math.
- 3. Complete standardized ELA and Math curriculum summaries in Grades K-8, which include consistent expectations for ELA and Math core instruction as well as Tier 2 and Tier 3 interventions K-4.
- 4. Complete standardized course syllabi for Grades 9-12 that include the following: standards, main concepts/essential questions, pacing, and key resources with links where appropriate.

- 2. Demonstrate overall increased participation in extracurricular activities at for both Middle School and High School students.
- 3. Offer at least five new clubs or extracurricular activities at the Middle School.
- 4. Using 21-22 extracurricular participation numbers as a baseline, develop a District plan to ensure an overall 10% increase of students who are engaged and/or demonstrate an interest in an athletic and/or extracurricular activity.
- 5. Survey K-12 students on their extracurricular interests, needs, and obstacles to participation.
