Introduction

The findings of a recent study showed that there is a significant benefit to students who participate in out-of-school-time (OST) programs. In fact, the [Return on Investment of Afterschool Programs in Pennsylvania](#) study determined that for every dollar invested in after-school programming for students there was a return of \$6.69 in potential benefits to students, including reduced rates for drop-outs, teen pregnancy, substance abuse, crime and delinquency ([Link to PSAYDN.org](#)).

In accordance with the American Rescue Plan (ARP) Act and Pennsylvania Act 24 of 2021 (Act 24), the Pennsylvania Department of Education (PDE) will award approximately \$50,000,000 or one percent (1%) of Pennsylvania's ARP Elementary and Secondary School Education Relief (ESSER) State Reserve funds to support school districts, charter schools and cyber charter schools (collectively, LEAs) in the development and implementation of comprehensive after-school programs to address learning loss in response to the academic, social, emotional and mental health needs of students and subgroups of students impacted by COVID-19 public health emergency that supplement school programs and activities.

Act 24 requires that, when available, existing personnel shall be utilized by school districts, charter schools and cyber charter schools to staff programs and activities established with these grant funds.

Within 90 days of receipt of these allocations, school districts, charter schools and cyber charter schools must submit a three-part plan to PDE, that outlines the proposed use of the grant money, itemized by program and activity. This plan is part of a consolidated application that includes after-school programming, summer programming, and a comprehensive plan to address learning loss. The plan shall include:

- 1) A description of each program and activity
- 2) A narrative outlining the expected benefit of each program and activity
- 3) A budget for each program and activity detailing personnel and operating costs

The District's after school program enrollment is based on student performance, or lack of performance. Grade and continued progress of all students is monitored on a regular basis by classroom teachers, guidance counselors, principal, parents and the Student Assistance Program for elementary (eSAP) and secondary (SAP) students. Student Referrals are reviewed by the respective SAP team with a sign off by the principal and students are added to the after school program as deemed necessary. Parents can submit their own request to have students added the after school program. These parental requests are also reviewed by the SAP teams and principal for a decision.

Students who are identified by parents and/or classroom teachers as struggling academically will receive academic-focused AfterSchool Academic Support to help improve their academic progress in their current curriculum. Marking Period grades for courses identified for each student will be monitored from entering the program until their academic progress improves enough to exit the program.

Classroom Teachers can recommend struggling students to either Student Assistance Program (SAP) or Principal for further academic support after school. Parents are contacted and have the afterschool program services reviewed with them as part of the recommendation for their student. Parents who are also aware of the program can also recommend their student for consideration by the respective SAP Team or Principal. Parents are communicated with as the student participates in the program. Continuous evaluations are done on participants to measure growth and progress and to determine if and when the student is able to exit the program.
