RELEASE AND AUTHORIZATION

I, the parent / guardian of the minor registered camper below, agree that he/she will abide by the rules of HoopEd and Rochambeau summer camp. I understand that the participation in any activity can result in possible injury or danger. I hereby release and discharge HoopEd and Rochambeau, all affiliated coaches, staff and associated personnel, including the owners of the fields and facilities used for the programs, against any claims by or on behalf of the registered camper as a result of the registered' s participation in the programs. In case of absenteeism, parents are asked to call/email HoopEd or Rochambeau. Children are not allowed to leave without written permission from the parent or guardian.

LATE POLICY: If your child is not enrolled in aftercare and you are late to pick up your child, your child will participate in the aftercare program for a fee of \$20. Additionally, if your child is in aftercare and you arrive after 6pm, there will be a \$1 a minute charge starting at 6:05. These fees must be paid at pick up.

CAMP PHOTOS: I agree to allow the use of all camper photos, videos, and likeness on the HoopEd and the Rochambeau websites, promotional materials including fliers, brochures, slide shows, and any other camp materials, and all HoopEd social media outlets. I hereby waive the right to inspect or approve the finished photograph, advertising copy, printed matter, or social media site that may be used for said registered camper.

CAMP CANCELLATION POLICY: Please note that we plan our staffing needs according to registrations in order to provide a safe, structured atmosphere for our campers. A 3-day notice is required to cancel your Day Camp registration (3 days prior to your campers start date). If you cancel before this time, you will receive a full refund less our \$50 processing fee per week per child. After the 3-day window, all fees are non-refundable.

A minimum of 10 students per day is required to open up the camp. If that number is not reached, then FIS and/or HoopEd has the right to cancel the camp. Full refunds are only issued if a program is cancelled by FIS or HoopEd due to insufficient enrollment. Pro-rated refunds will be issued for weather related cancelations. No refunds will issued for participant absences due to illness and make up days are not available
