

## ***Fall River Public Schools Home School Application Process***

---

Families who wish to home school their children must first submit the attached “*Notice of Intent to Pursue a Program of Home Education*” application. *Notice of Intent* applications, for both new and continuing proposals, should be sent, prior to beginning the Home Education Program, to:

Step 2: Upon receipt of the *Notice of Intent* Assistant Superintendent Tracy Curley will review the proposed home schooling plan.

Step 3: The parent/guardian will then be notified as to whether the plan is approved or denied. If the plan is approved, an approval notice will be signed by the Assistant Superintendent and Principal, and sent to the parent/guardian. If the plan is denied, the parent/guardian will be provided with the specific reasons for the denial so that the parent/guardian may revise and resubmit the plan.

Step 4: If the parent/guardian elects to proceed with implementing an approved *Home Education* plan, the parent/guardian must notify Assistant Superintendent of this in writing, either by signing and returning the approval notice to Assistant Superintendent Tracy Curley, or by otherwise notifying Assistant Superintendent Tracy Curley in writing of their decision.
