# STUDENT HEALTH

#### **Food Allergies:**

In the interest of our youngest students with food allergies, Dell Rapids Elementary School continues to be Peanut Aware. We ask that students and parents, please, not bring peanuts or peanut products into DRES or send them as snacks on field trips. We would greatly appreciate your assistance in helping us keep our students with food allergies healthy and safe.

#### **Latex Allergies:**

To protect our students with allergies to latex, Dell Rapids School District asks that latex balloons not be brought to school.

#### **Immunization Records:**

All new students to the school district (Early Childhood, K-Prep, Kindergarten, transfer, and foreign-exchange students) must have on record in the school office an up-to-date immunization record and a copy of his/her official birth certificate by the first day of school.

#### 6th Grade Immunization Requirements:

Since the 2016-2017 school year, the South Dakota Department of Health has included in their administrative rules the requirement of both the Tdap (Tetanus, Diphtheria, Pertussis) and MCV4 (Meningococcal ACYW) vaccines for entry into the 6th grade. Vaccine requirements for Kindergarten entry have been in place for many years. This will be the fourth year of this such requirement for 6th grade entry in South Dakota. Therefore, school entry requirements for South Dakota 6th grade students include:

✓ One dose of Tdap vaccine

✓ One dose of MCV4

These requirements apply only for 6th grade entry and transfer students 6th through 12th grade. If a child is 10 years old when entering the 6th grade, they have 45 days after their 11th birthday to be vaccinated.

#### **Medications:**

All students requiring medication administration during school hours must complete the proper forms. Please see the school nurse with any questions you might have.

# **TOBACCO/ALCOHOL & DRUG POLICY**

The Board of Education prohibits the use of all tobacco products in any building, vehicle, or bus owned/or operated by the school district.

#### ACCIDENT INSURANCE

The Dell Rapids schools do not carry insurance to pay for school related accidents. If an accident occurs, costs from the accident are the responsibility of the person involved in the accident. Individuals are encouraged to carry accident insurance.

#### ACTIVITY TICKET POLICY

The cost of an individual high school student activity ticket is \$20.00, and the cost of a middle or elementary student activity ticket is \$15.00. Activity tickets allow all-season admittance to most athletic events conducted by the Dell Rapids Public School and can serve as identification for student prices at other activities.

Each school building will schedule a time and method for purchasing activity passes, and passes will be available for purchase at the first home ballgames.

A family all-season athletic pass will be available for \$100.00. A family pass will include up to two adults (must be a parent or guardian) and all K-12 children living in one household. Other options for admittance to school activities include the adult 10-punch athletic pass for \$30.00 or adult all-season athletic passes for \$50.00 each. Regular contest athletic competition admission prices are \$5.00 for adults and \$3.00 for students, and \$6.00 and \$4.00 for double-header games, respectively.

Activity passes are non-refundable.

#### **SENIOR CITIZEN ACTIVITY PASSES**

Senior citizens (age 62 & over) who are residents of the Dell Rapids School District can receive free admission to most Dell Rapids Public School athletic events. A card will be required to receive free admission. Contact the District Office at 428-5473, option 1, for information on how to get this free lifetime pass.

#### **MY CHILD'S TEACHER**

What do I know about my child's teacher? The federal education law called the Elementary and Secondary Education Act (ESEA) requires that all parents in a Title I school be notified and given the opportunity to request information about the professional qualifications of classroom teachers instructing their child. If you are interested in this information, you may send your request to the building principal who will provide a response.

# FCCLA'S FIRST-EVER VIRTUAL NATIONAL LEADERSHIP CONFERENCE

Family, Career and Community Leaders of America (FCCLA) held its first-ever Virtual National Leadership Conference since the organization was founded in 1945. Instead of gathering in-person in the nation's capital as planned, members and advisors logged on to an online platform on July 7-9, 2020 which blended virtual reality and gamification technology to transform FCCLA's National Leadership Conference into a dynamic, "on-demand" virtual experience. This year's historic Virtual NLC was filled with keynote speakers, breakout sessions, leadership trainings, EXPO, Competitive Events, networking opportunities, adviser professional development, and more! More than 5,400 attendees from across the nation took part in FCCLA's Virtual NLC.

Nearly 3,000 FCCLA members from across the country participated in STAR Events this past June. STAR Events are Competitive Events in which members are recognized for their proficiency and achievement in chapter and individual projects, leadership skills, and career preparation. Two members from the Dell Rapids Chapter who qualified at the virtual state meeting held in April competed in their respective STAR Event category. Faithe Larson competed in the Fashion Construction category and Rylee Rinehart competed in the Sports Nutrition category. Both were awarded a Gold rating. Beverly Rieck serves as the advisor.

This year's conference theme encouraged members to write "Your Story," as well as reflect back over the past 75 years on how each member's story has helped write the organization's collective story. As

the year has progressed and the impact of COVID-19 drastically altered the planned pages of the stories originally envisioned, FCCLA was excited to be able to offer members an opportunity to continue to provide students with the Ultimate Leadership Experience they anxiously anticipate and prepare for all year.

Family, Career and Community Leaders of America is a dynamic and effective national student organization that helps young men and women become leaders and address important personal, family, work, and societal issues through Family and Consumer Sciences education. FCCLA has more than 182,000 members and 5,253 chapters from 48 state associations, Puerto Rico, and the Virgin Islands.

#### **Results from the Virtual FCCLA State Conference**

The SD Family, Career, and Community Leaders of America (FCCLA) Conference was held in April and was the first-ever virtual held meeting. Results of the competitive events and other awards were announced in May. The Dell Rapids FCCLA Chapter was recognized for their overall accomplishments over the year by receiving the Merit Chapter Award. Four members did compete in the STAR Event categories and all received a Gold rating. They include Abby Stauffenecker in Career Investigation, Desirae Hallem in Professional Presentation, Rylee Rinehart in Sports Nutrition, and Faithe Larson in Fashion Construction. It was then announced that Rylee and Faithe advanced in their respective categories and will now advance to national competition in June. The national event competition will also be held virtually due to the COVID19 crisis. Faithe is also serving as one of the seven state officers on the SD FCCLA Executive Council for the 2020-21 year. She was elected to serve in the capacity of First Vice President.

# **Ag In Action**

Summer 2020 has certainly been different! I have lost track of how many activities have been removed from my calendar. Included in the list are large gatherings, leadership camps, county achievement days and fairs, conferences, field days and farms shows that have been postponed or cancelled—limiting my ability to connect with others. As we continue moving forward in these uncertain times, I want to let you know I remain committed to providing students with an opportunity to gain knowledge and experience in the various areas of agriculture that can be utilized in their future to be successful.

Included in the agriculture education courses offered for the fall semester will be two sections of Introduction to Agriculture, Food and Natural Resources, One section will be during 2nd block and the other will be during 4th block. Those students will explore the role of the FFA organization in Agriculture Education, define and discuss the concepts of natural resources, demonstrate an understanding of animal science systems, demonstrate an understanding of plant structure and function, relate basic food science technology principles to production agriculture, summarize basic food science technology, and summarize basic principles involved in agricultural systems technology. Those students will also have the opportunity to learn about shop tools and shop safety, project design and construct a small wood project. This class will last the entire semester and will be worth one credit toward graduation.

The class offered during the first half of 3rd block will be Fundamental Ag Mechanics. The students enrolled in this class will have the opportunity to apply safety skills with engineering applications with mechanical equipment, structures, land treatment, power utilization and technology; exercise basic skills in blueprint and design development to create sketches, drawing and plans with estimate costs; develop skills required to use construction/fabrication equipment and tools; use a variety of concrete and masonry products; apply math and science principles to identify soil and water engineering and their properties. This class will last the entire semester and will be worth ½ credit toward graduation.

Ag Business Sales and Marketing will be offered during the second half of 3rd block. The students in this class will: examine skills necessary to obtain gainful employment in agribusiness occupations; examine effects of personality on job performance; use principles to accomplish an agribusiness marketing objective; use sales principles to accomplish an agribusiness objective; use computer technology and documents to manage agribusiness inventory; explore opportunities for marketing of agricultural products throughout the world. This class is also a half block class which will last the

entire semester earning students a  $\frac{1}{2}$  credit toward graduation as well.

Due to COVID-19, the FFA did not serve lunch to the students enrolled in driver's education, the Washington Leadership Conference was cancelled along with the state leadership retreats.

The sixteen acres of school land is utilized by the agriculture classes as a land lab and allows the FFA members to apply crop production skills. Troy Randall worked the land to prepare the seed bed for the planting of soybeans. Kevin Schnieders volunteered his time and equipment to plant soybeans on May 15. The soybean seed was donated by Ed's Produce, Dell Rapids CO-OP Grain Co., Sioux River Ag and Channel Seed. The soybeans will be monitored throughout the growing season by the FFA members and will allow students this fall to see and learn about crop production, fertility, pest management and grain marketing. The soybeans will be harvested this fall and the money brought in from the sale of the crop will go into the FFA account to fund all of the FFA activities throughout the year.

Any student enrolled in a high school agriculture education class during the fall semester or the spring semester is eligible to join the FFA organization and participate in the various activities and events throughout the year. #### **SCHOOL MEALS**

The Dell Rapids School District participates in the National School Lunch and Breakfast Programs. Lunchtime Solutions provides complete, well-balanced meals that are attractive and satisfying to students. All students are encouraged to enjoy the nutritious breakfasts and lunches.

Due to COVID-19 precautions in the fall of 2020, meal choices have been reduced in order to serve students as quickly as possible with social distancing. Grab and go breakfasts will be available to eat in designated seating areas. For lunch, elementary and middle school students will have one hot and one cold entrée choice each day. High school students will have the choice of a hot entrée, a sub sandwich, or a grill station sandwich. All lunches will include a vegetable, a fruit, and a choice of milk.

A limited number of a la carte items will be available for sale in the middle school and high school. Except for beverages, lunch snack items will only be sold to students who purchase a full meal. Second entrées and a la carte items must be selected as the student goes through the line for their meal, as students will not be allowed to return to the line. All selections will be deducted from the student's meal account, so parents/guardians should visit with their child(ren) about extra items they may or may not purchase. Lunch clerks will not be able to restrict purchases. Parents/guardians are encouraged to use the MySchoolBucks website to monitor their child(ren)'s purchases.

The student price for breakfast is \$1.55. The price for a

student lunch at the elementary school is \$2.90, and the daily price for student lunch at the middle school and high school is \$3.00. The price for an extra milk, or milk for elementary breaks, is \$.50. An extra entrée is \$1.80, and an extra pizza slice is \$2.00.

Applications for free and reduced price meals were mailed to each family and are also available in the principals' offices. Parents who have not received a direct certification notice, and who wish to apply for free or reduced price meals for their children, should return a completed application form to the business office.

The district uses NutriKids computer software for record keeping. Each student has his/her own lunch account, and the district requests advance payment. Any dollar amount can be deposited toward future purchases. It is strongly recommended that deposits into students' accounts be made online. Payments can also be given to building secretaries. Checks should be made out to Dell Rapids School, and the child's name should be written on the check. Cash payments are discouraged, and no payments will be accepted in the lunch line.

On the MySchoolBucks.com website, parents are able to view their child's account balance, access their child's eating history report for the past thirty days, and sign up for low balance notifications. The MySchoolBucks. com website is also a convenient, easy and secure online prepayment service to deposit money into a child's school meal account. There is no fee for making meal deposits online. More information on how to access this service is available on the district website at dr-k12.org.
