You also have a right to seek judicial review of your denial by filing a lawsuit in the State circuit court, 5 ILCS 140/11.

If you choose to file a Request for Review with the PAC, you must do so within 60 calendar days of this denial letter, 5 ILCS 140/9(a). Please note that you must include a copy of your original FOIA request and this denial letter when filing a Request for Review with the PAC.
