The Board of Education of the Mooresville Graded School District met in a duly noticed Called Closed Meeting and Called Work Session on Thursday, July 14, 2022, in the Professional Development Room at East Mooresville Intermediate School, 1711 Landis Highway, Mooresville, NC 28115.
