

Integrated Arts Academy Parking Rules:

Parking Permit \$60.00

Driving a vehicle to school is considered a privilege, not a right. Drivers are expected to know, adhere to, and accept the consequences for any violation of IAA parking rules. Integrated Arts Academy reserves the right to modify these rules at any time. IAA also reserves the right to search/tow any vehicle, and/or suspend or revoke student driving privileges.

Integrated Arts Academy Parking/Driving Rules

1. Motor vehicles driven on school grounds must conform to the regulations of the State of Minnesota, City of Chaska, and School District 112.
2. Students are to be respectful to others using the parking area.
3. Students are to park using only one parking spot.
4. Students are not to drive recklessly.
5. Students are not to move cars during the school day, except to leave campus legitimately.
6. Students are not to transport other students to or from campus during the school day.
7. Students are not to use vehicles to leave campus unexcused.

Violations

1. Parking outside painted lines
 2. Loitering/littering in parking lot
 3. Parking outside of designated student area
 4. Inaccurate family vehicle registration
 5. Visible tobacco products; smoking

6. Reckless driving/reckless behavior
 7. Transporting self or other student to/from campus during the day (including to/from Co-op)
 8. Insubordination to staff, failure to stop for staff
 9. Allowing another student to drive your vehicle

10. Refusal to allow vehicle search
 11. Possession/use of a weapon, controlled substance, paraphernalia, alcohol, fireworks, or contraband
 12. Vandalism

Minimum Consequences

Violations 1-5 have progressive consequences:

- 1st violation: Written warning to student
- 2nd violation: Five school days parking suspension
- 3rd violation: Revocation of parking privilege

Violations 6-9 have progressive consequences:

- 1st violation: Five school days parking suspension
- 2nd violation: Ten school days parking suspension
- 3rd violation: Revocation of parking privilege

Violations 10-12:

- 1st violation: Revocation of parking privilege
- Also possible tow/police report

Accidents:

Students drive and park on campus at their own risk. Any accident that occurs should be reported to Administrations and to the Chaska Police Department/Carver County Sheriff's Office.

Driving Another Student's Vehicle:

This is not allowed.

Driving to and from Campus:

Students may not travel during the school day, or transport other students without permission.

Field Trips:

Students are not allowed to drive to field trips.

No Parking/No Driving Zones:

Students are not to park in staff, visitor, handicapped spaces or crosswalks. A vehicle parked in a handicapped, visitor or crosswalk space may be towed and the owner fined.

Co-Op/CHS/CNHS:

Students are not to drive to or from the Co-op/CHS/CNHS except the first and last period of the day. Students may not transport students to or from the Co-op/CHS/CNHS.

Reckless Driving:

Minnesota Motor Vehicle Code 169:13 Subdivision 1. Reckless Driving: "Any person who drives any vehicle in such a manner as to indicate either a willful or wanton disregard for the safety of a person or property is guilty of reckless driving..." (Ex: speeding, exhibition driving, driving on the grass, pulling in front of drivers, not yielding to a pedestrian, revving an engine, screeching tires, sliding on the ice, whipping doughnuts, etc.)

Search of a Vehicle:

Any vehicle on campus is subject to a search by a school administrator. If the school official determines there is reasonable suspicion that a school regulation, a city law, or a state law has been violated, he/she may be assisted by a law enforcement officer. Anything in a student's vehicle is understood to belong to that student. All contraband (including, but not limited to, weapons, alcohol, drugs, fireworks, toilet paper, animals/insects and other items inappropriate or disruptive to the school environment) will be confiscated. Students with inappropriate items in their vehicles may be subject to additional school consequences. **Note:** Any student refusing to allow his/her vehicle to be searched thereby relinquishes the right to park on campus and must surrender the parking permit to the main office.

Suspension/Revocation:

When a student receives a suspension from the lot, the student and the vehicle are both suspended from parking at IAA. Parents/guardians of students with suspended or revoked parking privileges will be notified of the suspension or revocation by mail. Students, who drive/park on IAA lots without permission may have their vehicles towed. Students who have their permission suspended or revoked are not eligible to bring any vehicle to school for any reason.

Theft/Vandalism:

District 112 and IAA are not responsible for vandalism, injury, theft, or damage to vehicles or items therein in the school parking lot. Vehicles should be locked and valuables should not be in cars.

Transporting Another Student Off Campus:

Students may not transport another student to or from campus during the student day.
