Summary and Background Information

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund.

The federal ARP statute requires that States reserve ARP ESSER funds for three State-level reservations for evidence-based activities and interventions that respond to students' social, emotional, mental health, and academic needs and address the disproportionate impact of COVID-19 on students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children and youth in foster care, and migratory students.

Not less than 5 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, activities to address the academic impact of lost instructional time by supporting the implementation of evidence-based interventions.

Not less than 1 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, the implementation of evidence-based summer enrichment programs.

Not less than 1 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, the implementation of evidence-based comprehensive after-school programs.

The 2021-2022 enacted New York State budget fully allocated the required SEA reserves as subgrants to 398 LEAs and NYSED has made allocations to two additional LEAs. Specific LEA allocations are detailed in Columns D, E, and F in the [ARP ESSER Allocations Chart](#) (see also in the Document Library). Please note that these funds are in addition to the *90% LEA ARP-ESSER ALLOCATION* listed in Column C of that workbook and must be budgeted for separately.

As indicated in NYSED's approved [ARP ESSER State Plan](#), NYSED has included within this application a list of evidence-based interventions related to each state reserve. Studies have found that the strategy improves a relevant student outcome (e.g. reading scores, attendance rates). Students in these studies have not been randomly assigned, but researchers have used statistical matching methods that allow them to speak with confidence that the strategy results in an improved outcome. These studies meet the What Works Clearinghouse evidence standards with reservations. The studies use large, multi-site samples. No

other studies show that this strategy negatively impacts an outcome.

Tier 3 - Promising Evidence: Supported by at least one well designed, well implemented correlational study with statistical controls for selection bias. There is evidence that this strategy improves a student outcome (reading scores, attendance rates), but that research may consist of correlational studies -- studies can show a relationship between the strategy and outcome but cannot show that the improved outcome was the result of the strategy. The studies supporting Tier 3 strategies do not have to be based on large, multi-site samples. A strategy that would otherwise be considered Tier 1 or Tier 2, but it does not meet sample size requirements, is considered Tier 3. No other studies show that this strategy negatively impacts an outcome.

Tier 4 - Demonstrates a Rationale: High-quality research findings or positive evaluation suggests that this will likely improve student outcomes or other relevant outcomes; and there are ongoing efforts to examine the effects of such activity, strategy, or intervention. Based on existing research, the intervention cannot yet be defined as a Tier 1, Tier 2 or Tier 3. However, there is good reason to believe — based on existing research and data — that the intervention could improve relevant student outcomes.

In the space provided below, please describe how the LEA has meaningfully engaged a diverse and representative set of stakeholders to receive feedback in developing its plans to address the impacts of lost instructional time, provide summer learning and enrichment, and support comprehensive after school activities using State-Level Reserve Funds.

The district engaged stakeholders by sending out a survey asking stakeholders for input on how to spend the recovery funds. 191 stakeholders responded to the survey, 2.6% students, 80.6% parents, 18.8% community members, 3.7% professional support staff, 6.3% other district employees, .5% board member, and 3.7% representing a person with a disability (members could check multiple stakeholder groups). 74% of respondents prioritized student social/emotional/mental health and 68% of respondents prioritized adding staff to support academic learning loss. The district has added staff to support the social/emotional learning and developed district wide systems that include, daily check in of all students and community circles.

Administrators held staff meetings and employees gave input on how to spend the funds. The district will continue to meet and solicit input from stakeholders in regards to spending the COVID relief funds and how to implement the programming.

The district will share progress monitoring, grades, assessments in both academic and social emotional learning with parents. Parent/Teacher conferences will be held in the fall and spring. The district has contracted with BOCES for the services of a communication specialist to enhance communication to families in other ways, such as e-mail and social media. The district has added tutoring services, and is already a community school with many internal supporting organizations, such as Delphi Rise, Catholic Charities and Wayne Behavioral.

The practices listed below will address the academic, social, emotional, and mental health needs of all students, and particularly those students disproportionately impacted by the COVID-19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.

An universal practice in the district are daily community circles with students UPK-12. The lessons are planned by the PBIS team in each building to ensure equality throughout the district. The district also has a weekly outlook survey that students fill out indicating how they are doing emotionally. An universal social/emotional screener is used in grades 5-8 three times per year to help identify students in need of emotional support. The districts social emotional curriculum includes second step at the elementary level, life skills at the middle school level, and teen yourth mental health at the high school level. This is in additon to middle and high school health classes. All district staff has been trained in Restorative Practices and the district student handbook is being revised to reflect a restorative approach to student problems.

The district added Tier II positive behavior intervention specialist positions in each building. The specialist has built a team that looks at the above data, or by teacher request to identify students that need Tier II group supports. These supports include: Why Try, Check in/Check out, 2 x 10 intervention, targeted small group with second step review.

To determine academic needs the district has universal screening grades upk-8 to determine student needs. These screeners include Brigance for UPK, DIBELS K-3, Fastbridge 1-8, ixl 6-10, and other screeners and progress monitors in the Really Great Reading program UPK-3. Data meetings are held at each grade level to group students to focus on an academic need. Academic Intervention services are provided to students K-5. Time is built into the daily schedule for both reading and math. Dependent on need the students AIS group may be with a classroom teacher for enrichment or with a reading or math specialist for remediation.

To address student learning gaps and assist teachers in increasing high quality instruction BOCES instructional coaching services will be purchased in the following areas; instructional technology, literacy and math. The instructional technology coach will introduce the use of new digital instructional programs. The math coach will help the district update math practices and ensure the Next Generation standards are being followed. The literacy coach will help navigate the training teachers are receiving on the Science of Reading. All of these coaches will spend time with teachers in their classrooms implementing Best Practices which will assist in eliminating the gaps in student learning. Year 1 will focus on the elementary grades, years 2-3 will expand to include middle and high school.

The district will engage in high quality professional development for teachers/teaching assistance and district staff focusing in the areas of; prioritizing standards, social emotional well being of students, resiliency, literacy (focused on the science of reading) and math. The district will continue to offer professional development on technology integration.

The district will continue to provide academic intervention for all students, focused on individual learning gaps as determined on assessments. These assessments include, classroom unit tests, universal screeners, benchmark, and progress monitoring. These services are funded using Title I grant funds,

The district will continue to update curriculum materials for math and literacy. The review of curriculum materials has been ongoing through committee work funded using Title I sources. The district will continue to utilize the teacher leader model and mentor teacher model funded using Title IV funds. Lead and mentor teachers support district curriculum initiatives and new teacher development.

The district will provide a high school learning lab for all students to access assistance with academics. Funding will be used to furnish and staff this area for two years.

The district utilizes in house assessments as universal screeners and progress monitoring. These assessments provide information on specific areas of need and strengths for each student. These are reported to stakeholders with email updates, phone calls, report card grading, and parent teacher conferences.

The district is in year 2 of implementing curriculum grades UPK-3 focused on the Science of Reading. The district utilized STAR Renaissance last year to measure progress but has switched to DIBLES this year. Data meetings are held by grade level to determine individual student progress. Instruction is based off the areas of need as indicated on the assessments.

The district has a wide variety of Social/emotional learning supports funded using sources such as a Community School Grant, 21st century grant and an youth mental health grant. The district is fully engaged (year 5+) in practicing PBIS and Restorative Practices. The district will run an inhouse summer program for students in grades K-6 to offer both enrichment and intervention services to students, estimated at 150 students for two years.
