

The Forbes Road School Board met in the high school library for a special meeting held on Monday, June 28, 2022, at 6:30 pm. Board members present were Kathy Baker, Brian Barton, Robert Helman, Katherine Hollibaugh, Jordan House, Lori Kendall, Jim Lupey, and Stacey Wyles.

Additions to the agenda

The following additions were added to the agenda:

On a Hollibaugh/Lupey motion, approval was given to add an agenda item (p6), a discussion regarding the school board treasurer. Motion carried unanimously.

On a Wyles/House motion, approval was given to add agenda items (p9 & p10) to hire Natalie Shipley for the math teaching position and Mazie Husick for the physical education/health and driver's education (pending the completion of her driver's education certification). Motion carried unanimously.

There were no public comments.

Miscellaneous

On a Helman/Lupey motion, approval was given to appoint Rebecca Grandi to fill the vacant board seat; the term will end in November of 2023. Motion carried on an 8-0 roll call vote.

On a Lupey/Kendall motion, approval was given to repair the softball field as presented, to be completed by October 1, 2022. Motion carried unanimously.

Personnel

On a Helman/House motion, approval was given to accept the retirement letter of High School Principal and Biology Teacher, Randy Gelvin, effective July 31, 2022. Motion carried unanimously, with regret.

On a Kendall/Barton motion, approval was given to accept the retirement letter of Larry Brown, Maintenance, effective July 28, 2022. Motion carried unanimously, with regret.

On a Hollibaugh/Helman motion, approval was given to accept the resignation of Amy Horton, Varsity Assistant Field Hockey Coach, effective immediately. Motion carried unanimously.

On a Helman/Kendall motion, approval was given to appoint Jim Lupey to the JOC as a Forbes Road FCCCT board representative to fill the vacant seat. The term will end in 2022. Motion carried unanimously.

On a Lupey/Kendall motion, approval was given to appoint Robert Helman to the JOC as the Forbes Road FCCCT board alternate. Motion carried unanimously.

On a Hollibaugh/Lupey motion, approval was given to accept the resignation of Stacey Wyles as School Board Treasurer, effective immediately. Motion carried unanimously.

On a House/Helman motion, approval was given to appoint Kristie Hohman as School Board Treasurer, effective immediately. Motion carried unanimously.

Motion carried on a 7-1 roll call vote with board members voting as follows: K. Baker (Yes), B. Barton (Yes), R. Helman (Yes), K. Hollibaugh (Yes), J. House (Yes), L. Kendall (No), Jim Lupey, (Yes), S. Wyles (Yes).

On a Wyles/Lupey motion, approval was given to hire Mazie Husick for the physical education, health, and driver's education teaching position (pending completion of the driver's education certification) at a rate of \$38,500.

On a Lupey/Helman motion, board president Kathy Baker adjourned the meeting at 9:49 pm. Motion carried unanimously.
