WHEREAS, In addition to Master Agreements, the Equalis Group Purchasing Program may

from time to time offer Purchasing Group Members the opportunity to acquire

Products through other group purchasing agreements.

NOW, THEREFORE,

IN CONSIDERATION Of the mutual covenants contained herein and of the mutual benefits to result, the

parties hereto agree as follows:

- 1. Each party will facilitate the cooperative procurement of Products.
- 2. The procurement of Products by Purchasing Group Member party to this Agreement shall be conducted in accordance with and subject to the relevant federal, state, and local statutes, ordinances, rules, and regulations that govern Purchasing Group Member's procurement practices.
- 3. The cooperative use of Master Agreements and other group purchasing agreements shall be conducted in accordance with the terms and conditions of such agreements, except as modification of those terms and conditions is otherwise allowed or required by applicable federal, state, or local law.
- 4. The Lead Agencies will make available, upon reasonable request and subject to convenience, information about Master Agreements which may assist in facilitating and improving the procurement of Products by the Purchasing Group Member.
- 5. Purchasing Group Member agrees that Equalis Group Purchasing Program may provide access to group purchasing organization ("GPO") agreements directly or indirectly by enrolling Purchasing Group Member in another GPO's purchasing program; provided that the purchase of Products shall be at Purchasing Group Member's sole discretion.
- 6. Purchasing Group Member shall make timely payments to the distributor, manufacturer, or other vendor (each a "Supplier") for Products procured and received through any Master Agreement or GPO group purchasing agreement (each an "Equalis Agreement") in accordance with the terms and conditions of this Agreement and of the Equalis Agreement, as applicable.
- 7. Purchasing Group Member acknowledges and agrees that Equalis Group may receive fees ("Administrative Fees") from Suppliers, which are typically calculated as a percentage of the dollar value of purchases made by Purchasing Group Member under an Equalis Agreement. Equalis Group's standard Administrative Fees are two percent (2%) or less. Equalis Group shall provide Purchasing Group Member with access to a listing of Equalis Agreements that provide for the payment to Equalis of Administrative Fee in excess of three percent (3%). Additionally, Equalis Group shall provide Purchasing Group Member with access to an annual report listing Purchasing Group Member's purchases of Producgts through Equalis Agreements and the associated Administrative Fees received by Equalis Group.
- 8. Purchasing Group Member agrees that Products purchased under Equalis Agreements are for Purchasing Group Member sell, resell, lease, or otherwise transfer goods purchased through Equalis Agreements to an unrelated third party unless expressly permitted by the terms of the applicable Equalis Agreement.
- 9. Payment for Products and inspections and acceptance of Products ordered by Purchasing Group Member shall be the exclusive obligation of Purchasing Group Member. Disputes between Purchasing Group Member and any Supplier shall be resolved in accordance with the law and venue rules of the State of purchase unless otherwise agreed to by Purchasing Group Member and the Supplier. The exercise of any rights

- or remedies by Purchasing Group Member shall be the exclusive obligation of Purchasing Group Member.
- 10. Purchasing Group Member shall not use this Agreement or the terms and conditions of any Equalis Agreement as a method for obtaining additional concessions or reduced prices for similar products or services.
- 11. Purchasing Group Member shall be responsible for the ordering of products under this Agreement. A non-procuring party shall not be liable in any fashion for any violation by a party procuring Products under this Agreement. To the extent permitted by law, the party procuring Products shall hold any non-procuring party harmless form any liability that may arise from action or inaction of the party procuring Products. Without limiting the generality of the foregoing, Equalis Group Purchasing Program makes no representations or warranties regarding any Product or Equalis Agreement and shall have no liability for any act or omission by a Supplier or other party under an Equalis Agreement.
- 12. This Agreement shall remain in effect unless terminated by one party giving thirty (30) days' written notice to the other party. This provisions of Sections 5, 6, 7, 8 and 9 hereof shall survive any such termination.
- 13. If any term or provision of this Agreement is held invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction.

Subject to the preceding sentence, this Agreement will be binding upon, inure to the benefit of, and be enforceable by the parties and their respective successors and assigns. This fee shall be payable monthly commencing on the 30th of each month for which services have already been rendered for said month or any part thereof. Annual tuition shall be prorated commencing with the calendar month of enrollment. Tuition will be calculated on enrollment.

- 3. If any student is in attendance in an educational program of the Union County Educational Services Commission for any portion of a month, or though not in attendance, is enrolled and thirty (30) days notice, in writing, of withdrawal has not been given the Superintendent of Union County Educational Services Commission, the Edison Township Board of Education shall be liable for a full month's tuition as aforesaid. Withdrawal of a child during the month without said thirty (30) days notice shall immediately terminate this contract as to said student with tuition payable through the month, or two weeks following the date of withdrawal, whichever is greater.

IX. COMMITTEE REPORTS

1. BUDGET PLANNING AND OVERSIGHT COMMITTEE

June 21, 2022 – 4:30 P.M. to 6:26 P.M.

In attendance: Biral Patel, Brian Rivera, Jingwei "Jerry" Shi, Douglas Schneider, Bernard F. Bragen, Jr., Ed.D., Edward Aldarelli, Ed.D., Ann T. Kluck

Also in attendance: Gary Goldfarb, Mike Mouro and Jim Finn from Brown & Brown

Business Discussed:

- Mr. Finn presented on and shared the District's current year's claims data and what the projections should be in the future.
- He recommended that the District change the stop loss carrier from Voya to Horizon for the 2022-2023 school year, where the District will receive better coverage at the same price as last year. This was the best deal the District could receive for this coverage from over 12 reinsurance brokers and was approved at the last Board of Education meeting. The previous broker did not inform the District about the A4 retirement fund. Mr. Finn sated that the appropriate Stop Loss Protection for a district the size of Edison should be between \$3-\$5 million. The previous coverage was at the \$2 million level.
- Mr. Finn explained that the data revealed the District was underfunded in the first year and this
 necessitates the creation of health insurance Reserve Account to cover the full costs, should the
 maximum amount of possible claims be realized over the course of the next year. The numbers
 and projections provided by the previous broker were not close to the actuals paid. The previous

- broker had not provided the appropriate information in certain areas which impacted the District. The District anticipates that they will need additional funds placed into this reserve over the course of the next year and the Board of Education allocated a maximum of \$9 million to be moved from excess surplus.
- Prescription claims data was shared with the committee and indicates increasing trends in the future. The District's previous broker's commission was \$547,000 per year and the District's new broker's commission is capped at \$195,000 for all services for the 2022-2023 school year. The Broker recommends the Administrator and Auditor get together and discuss to fully fund over three years. There is no statute required but just the best practice. The Committee asked the broker to reconvene with the Committee after they have the Jun numbers for final information.

2. TOWNSHIP LIAISON COMMITTEE

June 14, 2022 – 11:00 A.M. – 12:00 P.M.

In attendance: Virginia White, Mohin Patel, Biral Patel, Bernard F. Bragen, Ed.D., Edward Aldarelli, Ed.D., Robert Dudash, Deputy Chief, Sgt. Douglas TurneerJoyce Ship-Freeman, Council VP, Margot Harris, Councilwoman, Assemblyman Robert Karabinchak (ZOOM), Robert Diel, Chief of Staff/Master Plan Coordinator (ZOOM), Ray Alcantara Mayor Chief of Staff (ZOOM), Sonia Alves-Viveiros Township Business Administrator (ZOOM) and Shivi Madhukar (ZOOM)

- Mr. Diehl provide information related to the Master Plan. The Committee meets monthly and represents all areas of the town. This committee will cover many issues and will hopefully resolve many existing problems. The last time the Master Plan was addressed was approximately 20 years ago. The committee is hoping to complete this project in a year.
- Assemblyman Karabinchak gave an update on different grants and programs that are available
 to all school districts. There is a Pilot Program for Electric School Busses. In addition, there is
 a grant for Bus security cameras, both inside and outside the vehicles. He was asked to provide
 the Committee with information for the Board of Education Grant Writer.
- Mr. Alcantara, on behalf of Mayor Joshi, reported that the mayor is moving forward on many projects from the Water Park to the Community Garden. Mrs. White asked about the proposed Recreation Center that will be adjacent to the Jets Football Field. It is supposed to house areas for wresting, cheerleading and basketball. She suggested that they include an Ice Rink. There is an Ice Hockey team in Edison that has to pay for ice time to practice and has to travel distances to do so.
- Deputy Chief Dudash gave an update on the Junior and Senior Police Academy's enrollment. It has increased particularly for the Senior Academy and the Juniors' are not far behind. This is great progress. In addition, they are providing Drug Education information to the Health Classes covering Opioids, Vaping and the dangers of marijuana.
- Sgt. Turner brought the Committee up to date with the progress of traffic issues that are being addressed around town. Jackson Avenue is moving in a positive direction. There are also traffic issues at Woodbrook and James Monroe Elementary Schools (signage). In addition, they are using flags to cross Plainfield Road by Woodrow Wilson Middle School for now. They are looking into New Dover Road and Tingley Lane to assess potential ways to help. Overall, all discussed traffic issues are moving forward in a positive direction.
- Mrs. Alves-Viveiros was introduced to the Committee and she will be included in meetings when she is available.
- The Edison Art Society has been very busy. The dedicated the new gazebo at Pappianni Park and introduced a new exhibit at the Municipal Building (Third Floor). Three scholarships were

awarded to undergraduates. There was one each for John P. Stevens and Edison High Schools and Middlesex College. Lastly, the painted pianos are back on Amboy Avenue. The next meeting is scheduled for July 12, 2022.

2. TOWNSHIP LIAISON COMMITTEE

July 12, 2022 – 11:00 A.M. – 12:15 P.M.

In attendance: Virginia White, Mohin Patel, Dr. Kevin Hajduk, Bernard F. Bragen, Ed.D., Edward Aldarelli, Ed.D., Assemblyman Sterley Stanley, Legislative Director/Aide to Assemblyman Stanley Verinda Sood, Councilwoman Margot Harris, Councilman Richard Brescher, Robert Dudash, Deputy Chief, Sgt. Lisa Cimmino, Ray Alcantara Mayor Chief of Staff (ZOOM), and Shivi Madhukar (ZOOM)

- Assemblyman Stanley spoke of extending for one year the useful life of school buses. He also stated that the Motor Vehicle Commission can also extend the bus life an additional year. He noted that the Electric School Bus bill was passing in the Assembly and Senate and is awaiting the Governor's signature. Mrs. White inquired about funding for security cameras both inside and outside school buses, as well as GPS location systems being installed on all buses. Mrs. Madhukar expressed that all school buses need to have cameras. She asked if the state would fund all hazardous bus routes.
- Assemblyman Stanley is sponsoring a bill (A3056) in the Assembly focusing on student mental health. The bill would grant students five (5) days of excused mental health days from school. He asked if the District is actively addressing student mental health issues. Dr. Bragen provided him with an overview of the District responses and procedures in place to address these critical issues. Assemblyman Stanley said that Edison is well ahead of the curve. Lastly, he mentioned another bill that allows for one absence to attend government functions. In addition, he proposed working with Mayor Joshi to create a Recreation Board to consist of citizens to develop long range improvement plans.
- Mr. Alcantara spoke about the new sports complex being created on Central Avenue and shared some preliminary drawings of the building.
- Deputy Chief Dudash introduced Sgt. Cimmino to the group. She will be replacing Sgt. Turn who has been promoted. He spoke about traffic concerns for arrival and dismissal at Woodrow Wilson Middle School. They are using flags to assist with crossing. The updated traffic pattern for Jackson Avenue during arrival and dismissal for Herbert Hoover Middle School will remain in place for the upcoming school year. The Crossing Guard issue has not been fully resolved, but they are working on coming up with solutions for the school year, including the possibility of privatizing. He also updated the Committee on the plans to offer more counseling and supportive services for families in crisis. The summer police academies for middle and high schools are filling up and are scheduled to take place in the upcoming weeks. He spoke of his goal to have more officers in schools to foster positive relationships with students.
- The Edison Art Society photography exhibit by Patricia McCarthy Rubin will be at the Municipal Building beginning July 28th to September 29th. A new mural of the flag-raising on Iwo Jima will be placed on the VFW 3117 building on National Road.
