# SUPPORTING YOUR CHILD'S TRANSITION FROM HIGH SCHOOL TO WORK, COLLEGE, AND TOOLS TO NAVIGATE INDEPENDENCE

Specialized Programs and Services will collaborate with parents and students to provide linkage and information necessary to access supports that assist with financial, medical, vocational, and independent living.

- Social Worker provides parents with information (electronic and written) and linkage to local services and supports for students and families.
- The information within the packet includes explanations and timelines to connect with various agencies and resources.
- Examples include: Social Security Administration, Options and Advocacy, Services Inc., Illinois Dept of Human Services, financial, medical, legal, recreational, and other community resources to support and empower parents and students within the D155 Specialized Programs to make educational decisions for transitioning into the community successfully.

# PARENT/STUDENT CHECKLIST 14 - 18+ YEARS OF AGE

The following is a list of transition guidelines that students, their families, and school personnel should consider as they plan for a student's transition from high school into adult services. This is just a beginning list of helpful local agencies and programs that can provide support and encouragement in planning for transition goals documented in a student's IEP meeting. *Information gathered from the McHenry County Transition Resource Directory* 



## AGE 14 1/2

□ Transition Planning is officially documented within the IEP

- □ Contact Options & Advocacy and Services Inc. to open a case, if one hasn't already been created (Autism Programming)
- Fill out the necessary paperwork to sign up for the PUNS list (funding source Prioritization of Urgency of Need for Services) (through Services Inc. The PAS/ISC Agency is Service Inc. Region A for McHenry County, (815) 338–0740– Joyce Rudicil, Program Manager, ext. 4118, jrudicil@svcincofil.org) This can be done as soon as a child is identified as having a developmental disability.
- □ Investigate assistive technology tools that can increase community involvement and employment opportunities
- Explore personal interests related to post-secondary education, employment, and independent living (information gathered for IEP meeting/courses)
- Begin forming future goals related to post-secondary education/training, employment, and independent living
- Determine strengths and needs through formal and informal Transition Assessments
- Understand transition and what that means for your child

### **AGE 15**

Begin identifying appropriate adult agencies in the community

- □ Sign releases for referrals to appropriate agencies at least annually at IEP meetings
- □ Reapply for PUNS funding
- Evaluate for vocational related skills and interests
- Obtain state ID as appropriate (obtain at Woodstock Secretary of State office, need a certified copy of birth certificate) <u>REAL ID-Mandatory by May 2023</u>
- Review and update transition plan

# PARENT/STUDENT CHECKLIST 14 - 18+ YEARS OF AGE

### **AGE 16**

- □ Check with an attorney or Service Inc. about guardianship, estate planning, a special needs trust, or opening an ABLE Account
- Refer to Vocational Rehabilitation or other appropriate agencies. DRS-Division of Rehabilitation Services. <u>IDHS- Rehabilitation (Online Referral)</u>
- Contact a Benefits Counselor (through DHS Department of Human Services) to provide more information on financial planning and employment (1-800-807-6962) www.dhs.state.il.us
- Explore part-time and summer employment options, if appropriate
- Begin job training at community sites or school vocational programs
- □ Sign releases for referrals to appropriate agencies at least annually at IEP meetings (Medicaid reimbursement, DRS, Service Inc., etc)
- □ Reapply for PUNS funding
- □ Identify and visit possible post-secondary schools/programming
- □ Review and update transition plan

### **AGE 17**

- Sign releases for referrals to appropriate agencies at least annually at IEP meetings
- Invite adult service providers to the IEP meeting
- □ Reapply for PUNS funding
- Apply for SSI in birth month and Medicaid two months prior to 18th birthday, if appropriate
- Plan for transition vocational training after graduation through the school (STRIVE Transition Program), if appropriate
- □ Check health insurance needs
- Discuss employment options or additional education training options
- □ Select post-secondary schools/programming and consider necessary accommodations (See accommodations request form)
- Review and update transition plan

# PARENT/STUDENT CHECKLIST 14 - 18+ YEARS OF AGE

## **AGE 18**

Sign releases for referrals to appropriate agencies at least annually at IEP meetings

- □ Reapply for PUNS funding
- Apply for SSI (Supplemental Security Income thru the Social Security Administration) if not already done <u>Social Security Income</u>
- Gather information, review, and identify necessary services, including transportation
- Arrange to meet with and tour adult service agencies and select appropriate service providers; confirm eligibility and status
- Depending on one's disability and services needed, he/she may receive educational services under IDEA for the duration of the school year in which they turn 22 years of age
- □ Review and update transition plan
- □ All males must register with the selective service <u>https://www.sss.gov/Home/Registration</u>
- □ Register to vote
- □ Seek guardianship if appropriate

# **P.U.N.S.** (PRIORITIZATION FOR URGENCY OF NEED FOR SERVICE)

PUNS is a statewide database that records information about individuals with developmental disabilities who are potentially in need of services. The State uses the data to select individuals for services as funding becomes available, to develop proposals and materials for budgeting, and to plan for future needs. Children, teens, and adults with developmental disabilities who need services or supports should enroll. PUNS selections are based upon funding availability and ability to fill program vacancies. Individuals selected from the database will receive a letter directly from the Department of Human Services announcing their selection and inviting them to apply for services by contacting their Independent Service Coordination (ISC) Agency (\*which is Services Inc for McHenry County).

Contact Services Inc. to open a case for PUNS. Be sure to let school personnel know that you are connected with Services Inc.and have applied for PUNS funding, so that information can be reflected in your child's IEP. You should apply for services by age 15 and reapply annually. If you have not done so before age 15, you can still sign up at any time.

# PLANNING FOR ADULTHOOD

# **OT** SHIFT FROM ENTITLEMENT TO ELIGIBILITY

When planning for your child's transition to adulthood, it is essential to realize a shift in how programming and supports are provided. As an individual from age 3 to 22, your child with a disability is entitled to a free and appropriate public education under the law. When your child continues at a community college, university, training program, or day program, s/he must qualify for services based on eligibility criteria determined by each organization. It is your child's responsibility to seek needed accommodations and services beyond age 22. Our goal is to help you access these integral transition linkages so our student's have a seamless transition from educational to adult services.



### SUPPORTING SELF-ADVOCACY

It is critical for your child to be able to talk about his/her disability and be able to share about his/her strengths and needs. If s/he will be attending college or gain employment, your child will need to be able to request accommodations for themselves. As mentioned above, it is your child's responsibility to seek needed accommodations and services once they enter post-secondary education or employment. As a junior or senior in high school, it is important for students with disabilities to begin taking more ownership in their education and begin self-advocating for their needs. There should also be more of a focus on their active participation in annual IEP meetings. This can be mirrored at home by permitting your son/daughter to have more responsibilities at home and/or converse with your child about the importance of speaking up for oneself and one's needs.

As a parent of an individual with more significant disabilities, it will be important for you to be able to articulate your child's strengths, needs, and accommodations they receive to an adult agency, if your child is unable to do so him/herself. All of this will be documented in one's IEP and Summary of Performance, upon exiting school programming. In addition, at school and at home, your child should be advocating for oneself. This may look differently for each student (i.e. utilizing visuals, short phrases such as "Too much" or "I'm nervous" or "I like this", or using full sentences using one's voice or assistive technology device). Self-determination and self-advocacy are very important for all students, especially those with disabilities.



### NAVIGATING THE COMMUNITY

Knowing all of the supports our community offers can be a challenge. This guide is meant to provide you with various sources of support for your child's specific needs and enhance his/her strengths. In many cases, families will seek the support of multiple services; school personnel and agencies will work together with you and your child to provide collaborative, integrated services.

# Service Inc. of Illinois

### Prioritization of Urgency of Need for Services – PUNS

- Enrollment in the PUNS waiting list is a very important service that Service Inc. provides. PUNS is a statewide database that tracks individuals who have indicated various types of support needs due to a developmental disability. It also serves as the state-wide waiting list the State of Illinois uses to select people for services.
- PUNS is for infants, children, adolescents, and adults. Service Inc. will complete a PUNS enrollment form for anyone who lives in McHenry County and has a developmental disability.
- Individual Service Coordinators will meet faceto-face with the individual and their family for the initial PUNS enrollment to ensure an understanding of the state's database/waiting list. Enrollment on the PUNS does not guarantee receipt of services, nor does it assume eligibility for services.

### Pre-Admission Screening (PAS)

 Any person suspected to have a developmental disability will meet one of our professional Individual Service Coordinators (ISC) and eligibility for state-funded services will be determined. Eligibility is obtained through in-depth interviews, compilation of historical documents and comprehensive assessments. Once eligibility has been confirmed, the ISC will assist the individual and their family with exploring the service options that will support and address the individual's current needs.
