## OUR SCHOOL:

Boys' Latin of Philadelphia prepares boys for success in college and beyond. Founded in 2007 to address the dearth of quality educational opportunities for boys in Philadelphia, today the school provides a world-class college preparatory education to 800 young men in grades six through 12, the vast majority of whom are African American and Economically Disadvantaged. The only all-boys public school in Pennsylvania, the school boasts an intimate learning community in which each young man is encouraged to be the "architect of his own fortune". We provide a rigorous academic model, blending classical education and contemporary pedagogy, which prepares students for college matriculation and sets high standards for achievement, character development, and emotional intelligence. Our curriculum features daily Latin classes, AP or Honors sections in every subject area, a 1:1 laptop program, and diverse course offerings. Boys' Latin students attend an extended day of classes, receive after-school tutoring, and have Saturday classes. Learning is underscored by practical experiences and extracurricular activities to develop students' intellectual, moral, social, creative, and athletic potential.

Over the past decade we have built an effective model for educating minority boys, a demographic that suffers the worst educational and quality of life outcomes in the nation. We firmly believe that all students, regardless of background, are capable of going to, and graduating from college. Since our first class graduated in 2011, Boys' Latin students have matriculated into and persisted through college at rates three- to four-times greater than Philadelphia averages.

## Sample Educational Improvement Tax Credit Calculation:

Pennsylvania Tax Bill	\$10,000
Donation Amount	\$10,000
Tax Credit, based on 90% rate	\$9,000
Federal Tax Savings, based on a 35% rate	\$350
Savings	\$9,350
Net Cost	\$650
