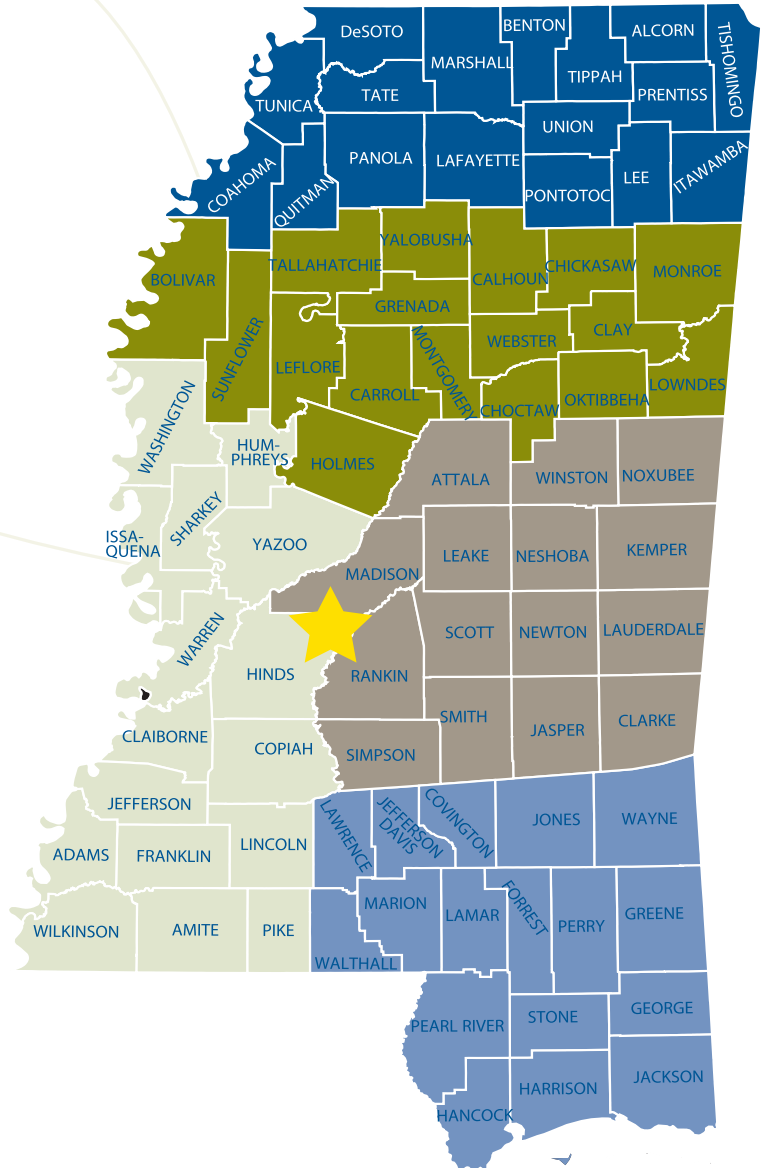

1. To start the enrollment process, make sure you have the following information:

- Plan Enrollment Code: **KdxBm8Sc** (expires 10/1/2022)
- Group ID / plan number: **98949-01**
- Social Security number
- Current annual income
- Date of hire
- Full division name (name of your employer)
- Beneficiary information (Social Security number, birth date, phone number, and mailing address)

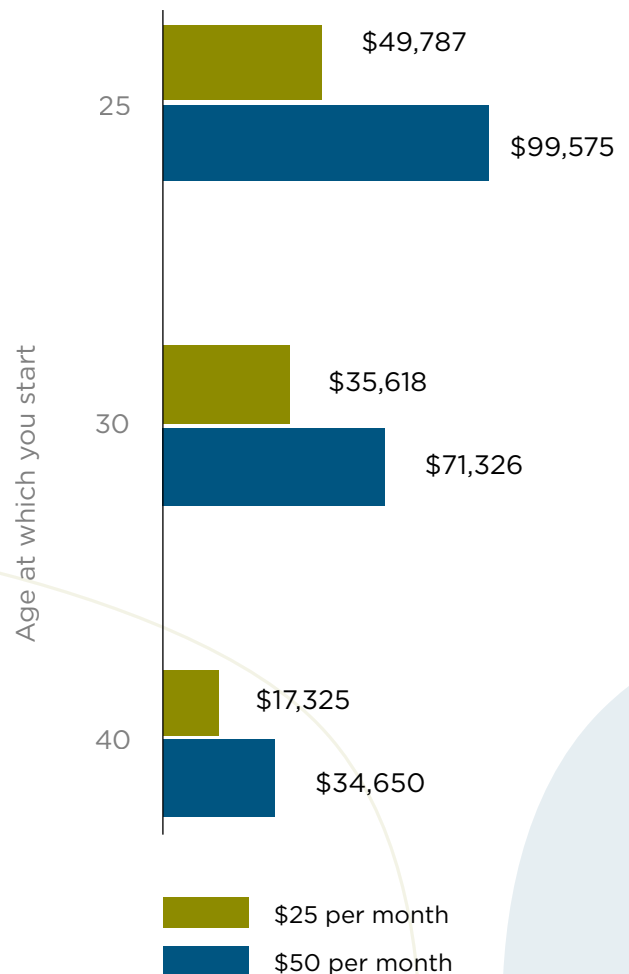
2. To enroll online:

- Visit **www.mdcplan.com**
- Click on *REGISTER* under *Participant Login*
- Select the *I have a plan enrollment code* tab
- Complete your information and follow the prompts to complete enrollment
- The enrollment process will be complete after you select *Enroll Now* at the end of the guided process
