Remarks should be brief and concise, with a maximum length of three minutes (about 450 characters). Comments should start with a 2-3 sentence summary that will be read instead of the entire message in the event that there is a large number of comments and reading each of them in their entirety would extend beyond the time allotted for public comment. **Public comments will be accepted by 1pm on the day of the meeting.**
