Motions carried unanimously.

On a Baker/Bolinger motion, approval was given for the following agenda items: (7) amendments to the School Safety grant (8) revision to the crisis operations plan (9) staff procedures for active shooter emergency. Motions carried unanimously.

On a Bolinger/Baker motion, approval was given for summer hours, 4 day work week. Motion carried unanimously.

On a Bolinger/Baker motion, approval was given to hire CES Engineering, LLC to evaluate the front wall structure of the school building and give recommendations for repair. Motion carried unanimously.

On a Baker/Hall motion, approval was given to congratulate Mr. Gelvin, Mr. Kuhns and the boys' baseball team on their District 5 Title. Motion carried unanimously.

On a Baker/Hall motion, approval was given for medical leave for Superintendent Mark Loucks. Motion carried unanimously.

On a Bolinger/Arnold motion, approval was given to appoint Mrs. Maria Scott-Bollman as Interim Superintendent in the absence of Superintendent Loucks until further notice, effective June 5, 2019 at a stipend of \$60.00 per day. Motion carried unanimously.

The board went into executive session for the second time in the evening from 8:53 pm-10:25 pm for personnel reasons.
