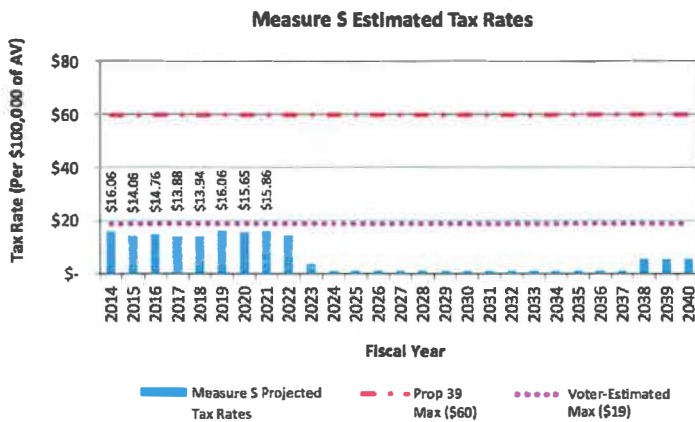




Tustin Unified School District Measure S Annual Report for Fiscal Year 2020-2021

Dear Tustin Unified Community Members:

The TUSD Measure S Citizens' Oversight Committee is excited to report our findings on the fiscal responsibility of the District and the progress made with bond dollars up to and including the 2020-21 fiscal year. Measure S is a \$135 million dollar Proposition 39 technology bond that was passed on November 6, 2012. The bond measure earned 60.1% of the vote, but needed only 55% to pass. To date, two issuances of funds (Series A and Series B) have been authorized that total \$55 million dollars, and the tax rate remains well below the estimated ceiling of \$19 per \$100,000 of assessed value for home owners. It is clear to the committee that the goals of Measure S are being pursued with intention and responsibility by the TUSD staff trusted with our funds. While only a limited number of Measure S expenditures were made during the 2020-21 fiscal year, a portion of Series A bonds were refinanced in March of 2021. This refinancing should result in a projected \$1,557,518 of tax payer savings over the life of the refinancing (Keygent 8/30/21).



Measure "S" Goals Include:

- Creating powerful and sustainable internet network infrastructure.
- Providing all teachers and students access to modern classroom technology.
- Issuing student and teacher devices that support rigorous and engaging instruction.
- Offering experience with industry standard equipment in Career Technical Education (CTE) programs.
- Updating aging STEM Lab facilities.

The work of the Measure S Citizens' Oversight Committee involves the oversight of your bond tax dollars, direct participation in financial audit processes with third-party auditing firms like Nigro & Nigro, hearing presentations from TUSD staff and touring schools to see both bond funded construction projects and technology. Measure S and the instructional practices associated with it in every classroom across TUSD have become models of best practices for school districts throughout the state of California. Transparency and effective communication are also important to our committee and District, and have resulted in the posting of all meeting minutes, financial audit reports, and other documentation critical to the execution of Measure S being posted on the TUSD Website at www.tustin.k12.ca.us. As the Chair of the TUSD Measure S Citizens' Oversight Committee and as a Certified Public Accountant, I am extremely proud of the work happening with our community's bond dollars.
