*Lycoming Career and Technology Center is committed to providing in-person learning to the maximum extent possible. The school will continue to consider information and guidance received from the Center for Disease Control, the Pennsylvania Department of Health, and the Pennsylvania Department of Education.*

*Lycoming Career and Technology Center will continue to work with our sending districts to provide a broad range of services to ensure the continuity of services including technical skills, academic, social, emotional and mental health needs. Technical training and academic needs will continue to be addressed including assessment of student data, learning loss. LycoCTC will provide in-service training to support staff with meeting student needs. We will utilize our sending school resources such as counselors, school outreach worker, trauma counselor, outside mental health and support agencies and mental health programs. The continuity of services will continue regardless of the in-person or remote learning.*

<p>a. <b>Universal and correct wearing of <a href="#">masks</a>;</b></p>	<p>Masks are optional in school buildings, on school grounds, and on LycoCTC provided transportation. Students and staff will not be required to wear face coverings except as required for the safe operations of tools and equipment. Students and staff will not be discouraged from choosing to wear a mask to help prevent the spread of disease. The JOC may convene to address new orders or recommendations concerning masks.</p>
<p>b. <b>Modifying facilities to allow for <a href="#">physical distancing</a> (e.g., use of cohorts/podding);</b></p>	<p>Maintain normal operating procedures related to moving and interacting within our school.</p>
<p>c. <b><a href="#">Handwashing and respiratory etiquette</a>;</b></p>	<p>Students and staff will continue to practice safe and healthy hygiene practices. This includes both handwashing and respiratory etiquette.</p>
<p>d. <b><a href="#">Cleaning</a> and maintaining healthy facilities, including improving <a href="#">ventilation</a>;</b></p>	<p>We will follow recommended guidelines for cleaning, disinfecting, sanitizing, and ventilation practices already established.</p>
<p>e. <b><a href="#">Contact tracing</a> in combination with <a href="#">isolation</a> and <a href="#">quarantine</a>, in collaboration with the State and local health departments;</b></p>	<p>We will work with sending districts and the Pennsylvania Department of Health regarding contract tracing of students. We will continue to apply the most recent guidance and procedures on isolating and quarantining as provided by the PA DOH, PDE, and the CDC as follows:</p> <ol style="list-style-type: none"> <li>1. <p>f. <a href="#">Diagnostic</a> and screening testing;</p>	<p>The school will ask individuals to consult their primary care physicians to make any diagnostic or screening testing.</p>
<p>g. Efforts to provide <a href="#">vaccinations to school communities</a>;</p>	<p>Vaccinations are encouraged but not required for students and staff. LycoCTC may share information regarding vaccination opportunities with students and staff.</p>
<p>h. <b>Appropriate accommodations for students with disabilities with respect to health and safety policies; and</b></p>	<p>LycoCTC will offer a free and appropriate public education for all enrolled students. This includes appropriate accommodations for students with disabilities including any necessary modifications with respect to our health and safety policies.</p>
<p>i. <b>Coordination with state and local health officials.</b></p>	<p>We will continue to work with both state and local health officials to ensure the health and safety of our students, staff and community.</p>
