Respond to the statements below

- 01. A 16 passenger van may be a Type III bus.
- 02. The School District is responsible for the proper functioning of the bus
- 03. Minnesota law requires that all people who drive students on buses receive training.
- 04. All passengers must be seat belted before moving the bus/van
- 05. Cell phones may be carried on the bus by the driver
- 06. Safety equipment is only used in emergencies
- 07. The back door may be locked when driving in dangerous areas.
- 08. A Type III bus normally stops for RR crossings unless they are marked "exempt".
- 09. Your school should always know where you will be when driving students.
- 10. Turn on headlights only when it is dark or there are passengers on the bus
- 11. Stay in the same lane through the whole transit of a roundabout.
- 12. Roundabouts are more dangerous than traditional intersections by and large.
- 13. Get back to the school district in bad weather at all costs
- 14. Having a beer is okay when not driving students for at least 4 hours
- 15. Drivers shall have a cell phone available for emergencies

When riding in a Type III bus or Activity bus;

- 16. students must stay in their seats

When picking up or returning the Type III or Activity bus, the driver shall

- 20. Inspect the vehicle and have any mechanical issues resolved before driving the bus.

- 23. if the fuel is low, make a note so it can be filled up before the next trip
- 24. in winter make sure the front windows are clear of snow and frost
- 25. leave the key in the bus for the next driver

Crash and emergency response activities

- 01. If you have been involved in a minor traffic crash, the first thing you do is check to see if your students are injured.
- 02. If you have a fire on your bus, first get the fire extinguisher and put it out
- 03. Move your bus after a crash only when authorized by police or district staff.
- 04. In the event of an accident, immediately check to see if the bus is in a safe location.
- 05. After an accident it is necessary to make a list of all injured students on your bus.
- 06. If you are in a moving vehicle accident, you need to file a police report
- 07. When you have injured students, you must first call 911.
- 08. If you think you are at fault in an accident, keep it to yourself.
- 09. You should let officers take charge, since your first responsibility is your students.
- 10. If a driver is arrested for any moving violations, he or she shall report the incident to the transportation office before driving the vehicle again.
- 11. When involved in a crash, you must share your information with the other driver.
- 12. After an accident, you should immediately call your principal/supervisor
- 13. Write up an accident report only if you were the registered driver of the vehicle
- 14. After an accident, the State Patrol will inspect your vehicle for defects.

Driving questions

- 15. The major goal of Defensive Driving is Collision Prevention through Hazard Recognition
- 16. Distracted driving contributes to approximately 100,000 injuries annually in the US.
- 17. When you are driving down the road and you observe other vehicles to see if they could be a hazard to you are driving in a defensive driving mode.
- 18. Texting and driving is the most dangerous because it requires visual, manual and cognitive attention.
- 19. The greatest cause of distracted driving accidents is daydreaming.
- 20. When driving in a roundabout, you always yield to entering traffic on your left.
- 21. Roundabouts reduce fatal intersection accidents by more than 75%.
- 22. When your brain is multi-tasking, it is really switching from task to task, not working on both simultaneously
- 23. While driving, talking on the phone hands free is no safer than talking on the phone in hand.
- 24. The average interval that eyes are off the road when a driver is texting is about 5 seconds.
- 25. When you are talking on the phone you see approximately 80% of the driving environment.
