The proposed work is within regulated wetlands and watercourses areas and within 150 ft. upland review areas. (Submitted for IWWA receipt on August 8, 2022. Determined to be potentially significant and set for public hearing on September 7, 2022. Permit approved with conditions on September 7, 2022.)

(Submitted for TPZ receipt on August 8, 2022. Required public hearing scheduled for September 7, 2022. Permit granted with conditions on September 7, 2022)
