

## **AGREEMENT AND WAIVER**

This AGREEMENT AND WAIVER (hereinafter the "Agreement") is made by and between \_\_\_\_\_ (hereinafter the "Parent"), individually and as parent of \_\_\_\_\_ (hereinafter the "Student") and Regional School District No. 14 (hereinafter the "District").

WHEREAS, the Parent and the Student are residents of the Town of \_\_\_\_\_;

WHEREAS, the Student is a member of the \_\_\_\_\_ Team (hereinafter, "the Team")

WHEREAS, the District generally provides transportation of student athletes to and from games and matches, and as such, the District generally provides transportation of members of the Team to and from matches, games and other Team events taking place outside of the Towns of Woodbury and Bethlehem;

WHEREAS, whenever such transportation has been provided, it is expected that students will use this transportation to travel to and from the events in which they participate except under special conditions;

WHEREAS, notwithstanding the foregoing, due to convenience and/or issues with student transportation in light of the shortage of bus drivers, the Student may not be receiving transportation to all such Team events but rather may choose to be transported by said Student or the Parent to and from some or all such events;

WHEREAS, the District and the Parent wish to cooperate in permitting the Student to travel to and from (and attend) such Team events under this arrangement, so that the Student may enjoy the privilege of participating in Team events;

NOW, THEREFORE, in consideration of mutual promises and forbearances of the parties, it is hereby agreed as follows:

1. The Parent and the Student acknowledge, elect and agree that said Student will not receive transportation to and from any and all such Team events during the 2022-2023 season. Rather, the Student will be responsible for securing transportation to some or all said events, whether by way of the Parent or the Student (should the Student not utilize District provided transportation).

2. On all occasions where the Student traveled with the Team on a bus to the event but does not return with the Team on the bus from said event, the staff member in charge of the event must make verbal contact with the Student or Parent that transports the Student home.

3. The Parent shall protect, defend and hold the District (and any of its agents, members, and employees) harmless from any claims or liability of any kind whatsoever for personal injuries or property damage or any other loss suffered or incurred by the Parent, the Student or any other individual(s) in the course of or in connection with this Parent or Student transportation. The Parent and the Student assume all risk for such Parent or Student provided transportation.

4. This Agreement constitutes the full agreement and understanding of the Parties. The Parties both acknowledge and agree that they have read this Agreement in its entirety, understand all of its terms and conditions and obligations that they are assuming, knowingly and voluntarily assent to all the terms and conditions contained herein, and are entering into this Agreement knowingly and willingly.

5. The parties represent and agree that this Agreement shall be interpreted in accordance with the laws of the State of Connecticut. Each term and provision of this agreement shall be valid and enforceable to the fullest extent permitted by law and any invalid, illegal or unenforceable term or provision shall be deemed replaced by a term or provision that is valid and enforceable and that comes closest to expressing the intention of the invalid, illegal or unenforceable term or provision

6. This Agreement shall expire on June 30, 2023.
