## Device User Agreement

The Pendleton County School District (PCSD) recognizes that digital media, including the Internet, provides access to a wealth of instructional resources. In certain circumstances, instructional needs may warrant the use of PCSD technology at home, including but not limited to, Windows laptops, WinBook, and iPads. The following outlines the expectations for acceptable use of these devices.

- Devices fall under the PENDLETON COUNTY Student Handbook. While at school, the device used will be monitored through district level technology department. Anyone found violating acceptable use will be subject to disciplinary actions. All devices referenced in this Agreement are hereinafter referred to as "Equipment."
- Use of PCSD technology, including access to the Internet using PCSD technology, must conform to the district's Acceptable Use Policy and the companion document in the PCSD Student Code of Conduct even while the Equipment is not connected to the PCSD network.
- Parents/guardians must supervise their child's Internet use on the Equipment while at home.
- Only the student listed below may use the Equipment listed below.

By signing this, you agree to abide by the terms herein. I understand that should I fail to honor all these terms, PCSD may deny future network, Internet, and/or other digital media accessibility provided by the PCSD. I further agree to use the Equipment in a lawful, careful and prudent manner in accordance with the specifications of the manufacturer(s) of the Equipment. Other than normal wear and tear, I agree to pay for all damages to the Equipment resulting from use or from any negligence on the part of my child or myself. If the Equipment is damaged, to the extent the Equipment cannot be repaired for its intended use, I will compensate PCSD for the full replacement cost of new Equipment. Furthermore, I may be subject to disciplinary action outlined in the PCSD Student Code of Conduct and, if applicable, PCSD may recall the Equipment.

I understand that all devices are the property of the Pendleton County Schools and must be returned to PCSD upon request of PCSD.
