SUBJECT: Conduct Interviews and Approve Provisional Appointment of Board Member for Unexpired Two-Year Term

BACKGROUND: Trustee Nathalia Hughes Erskine submitted her resignation to the Superintendent stating that she would resign from the TUSD Board of Education as of August 22, 2022.

The School Board, after interviewing candidates, intends to appoint a person to fill the resulting vacancy (an unexpired two-year term). Pursuant to California Education Code, the Board has the authority to appoint a member to carry out the balance of the unexpired term.

RATIONALE: The District's press release invited those interested in being on the board to apply by submitting their application and resume to the Superintendent's Office no later than 5:00 p.m. on September 13, 2022. Interviews will take place and a candidate will be selected at a special board meeting. The replacement board member shall take office immediately.

FUNDING: There is no cost to this agenda item.
