# How is the Educator Effectiveness Fund calculated?

*Allocation of funds is calculated according to the number of full time **certificated** and **classified** employees reported in CALPADS as of Oct. 2020*

*$\$2,415 \times 60$  **certificated and classified employees** (teachers, counselors, administrators, paraeducators)*

*= **\$145,914***

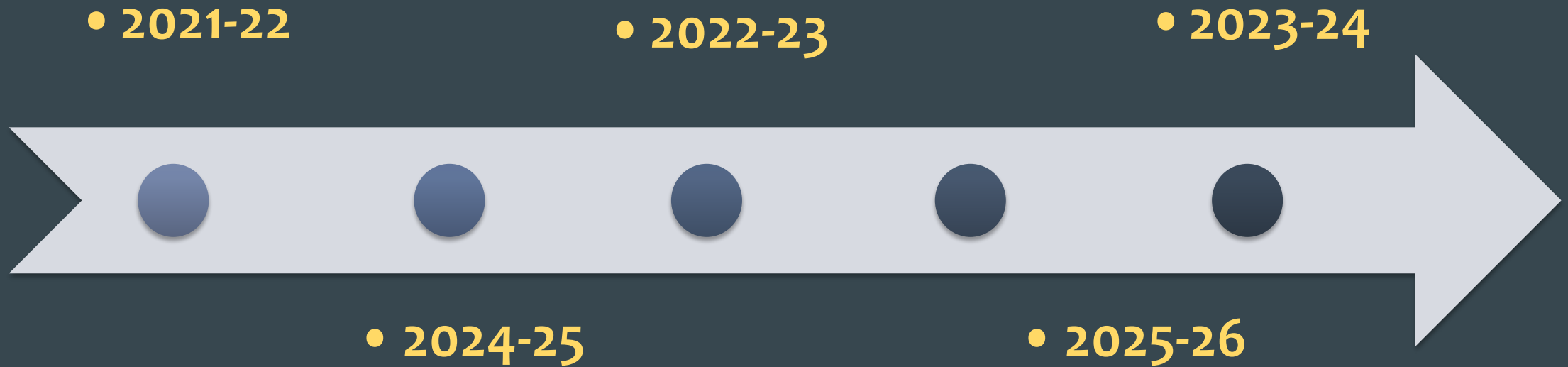
