### **Bullying Investigations**

Conn. Gen. Stat. 10-222k provides that the superintendent must appoint a "Safe School climate coordinator", and that the principal of each school will serve as the "safe school climate specialists" for the school with the responsibility for investigating bullying complaints and maintaining related records.

In addition, Conn. Gen. Stat. 10-222k further states that each school must have a committee (or charge an existing committee) with responsibility for developing and fostering a safe school climate and addressing issues with bullying in the school.

Conn. Gen. Stat. 10-222d requires that school boards adopt "safe school climate plans" to address the problems of bullying in the schools, and submit such plans to the State Department of Education for approval.

Conn. Gen. Stat. 10-222p states that school officials must administer a school climate survey in each school every two years, "using the school climate assessment instruments, including surveys, approved and disseminated by the Department of Education pursuant to section 10-22h, and send the results to the Department.
