A. PURPOSE OF REPORT

- a. At the August 11 Workshop meeting the board discussed the live streaming of workshop meetings.
- b. Currently the workshop meeting is set up to create an environment where board members can engage in conversation and dialogue around topics on the agenda and it is not live streamed for the public. Board members and Executive Cabinet members are arranged in various formats that do not always allow for table conversations to be picked up when by portable microphones when recorded.
- c. The regular business meeting for each month is live streamed and the board assumes their positions at the dais with the permanent microphones.
- d. The additional cost to return to live streaming the workshop meetings would be approximately \$2,760 for a total of \$12,260 per year (quote attached).
