 ceremonies. He also commented on the challenging school year, how poor student attendance is
 disheartening. He also expressed his hope the movie "Selma" would be shown.
- Mrs. Makulec spoke of the flag box in the District's lobby for placement of American flags that need to be
 retired. Once flags are retired, there is a ceremony for them. She also reminded everyone of Amazon Smile
 and that Rockford Promise is on the list that receives donations through purchases made.

- Dr. Jarrett gave a brief overview of the Board Governance calendar. Drafts of the three major committee calendars will be previewed in July. Dr. Jarrett asked members to e-mail him with any questions.
- B. Title I Presentation Dr. Woulfe, Dr. Brown, Mr. Gallagher

The overview consisted of the definition. Title I, Part A provides financial assistance to local educational agendas and schools with high numbers or high percentages of children from low-income families to help ensure that all

children meet challenging state academic standards. Title 1, 1003 (a) is to provide all children significant opportunity to receive a fair, equitable and high-quality education and to provide adequate resources to substantially raise the achievement of children in lowest-performing school. Rules for spending were reviewed. Proposed purchases or service costs should be reasonable, necessary, and allocable. The summary for FY22 Title I and IV Dollars is: \$29,175,049, carryover of \$10,431,647 (due to the pandemic, Districts were allowed to carryover excess funds), for a total of \$39,606,696. The summary of projected FY23 Title I and IV funds are: \$23,215,196, carryover of \$4,518,325 (15% carryover) for a total of \$27,733,521. Schools with Title I funds are Auburn, East, Jefferson, Eisenhower, Flinn, Kennedy, Lincoln, RESA, West, Barbour, Bloom, Carlson, Cherry Valley, Conklin, Ellis, Froberg, Gregory, Haskell, Hillman, Johnson, Constance Lane, Lathrop, Lewis Lemon, McIntosh, Riverdahl, Rolling Green, Washington, Welsh, West View, Whitehead, Galapagos, Jackson, and Legacy, Targeted assistance for private schools is All Saints Academy, Alpine Academy, Alpine Christian. Boylan, Cathedral Baptist, Christian Life, Concordia Lutheran, Holy Family, Keith Day, Kikifers, Montessori Private, Our Lady of the Sacred Heart, Rockford Christian, Rockford IQRA, Rockford Lutheran, Spectrum, St. Bridget, St. Rita, and North Love Academy. Schools not served are Roosevelt, Marshall, Marshall Elementary, Guilford, Brookview, Montessori, Spring Creek, and Early Childhood sites. Targeted assistance for underperforming schools served with Title 1, 1003(a) funds are Jefferson, Eisenhower, Bloom Carlson, Cherry Valley, Hillman, Johnson, Constance Lane, Lathrop, Rolling Green, Spring Creek, Washing, West View, Whitehead, and Galapagos. Comprehensive support for lowest performance schools is Auburn, East, Flinn, Kennedy, Lincoln, RESA, West, Conklin, Ellis, Haskell, Lewis Lemon, McIntosh, Riverdahl, Welsh, and Jackson. Extensive discussion took place regarding the subject matter. Board members asked for trend data by site and how the schools decide to spend the funds.
