

ATLANTIC HIGH SCHOOL PARKING APPLICATION

PARKING AT ATLANTIC HIGH SCHOOL IS A PRIVILEGE. ALL VEHICLES MUST BE PROPERLY REGISTERED.

QUALIFICATIONS

To qualify for an AHS Parking hang tag, a student must:

1. Have a 2.5 GPA for the previous grading period.
2. Provide a copy of their valid driver's license (attach a copy).
3. Provide a copy of the vehicle's current registration.
4. Provide a copy of the vehicle's current insurance card
5. Signed parent permission form
6. All obligations must be **Paid In Full** before being able to get an AHS Parking hang tag.

A student's parking privilege may be revoked/suspended including but not limited to the following reasons:

1. Failure to maintain a 2.5 GPA during any grading period.
2. Excessive discipline or a major discipline referral.
3. Allowing another student to drive your vehicle.
4. Unauthorized absence from campus.
5. Taking any student off campus without authorization from the school.
6. Using an AHS Parking hang tag not assigned to you.
7. Three parking violations.
8. Reckless driving and/or speeding in the parking lot or within the perimeter of the school.
9. Using the vehicle to leave campus when unauthorized.
10. Habitual tardiness to any class.
11. Not returning from lunch without a parent contact on that day.

NOTE: A \$10.00 reinstatement fee will be accessed to those students whose AHS Parking tags have been suspended.

TRANSFER

To transfer an AHS Parking hang tag from one vehicle to another, a student must have:

1. Current registration for the new vehicle.
2. Remains of the old AHS Parking hang tag.

TEMPORARY PERMITS

This permit should be obtained before first period from the Shark Resource Center [SRC]. The cost of the permit is \$1.00 per day. Temporary permits are not allowed if your parking privileges were revoked.

MISCELLANEOUS

1. Students must leave their cars and come on campus as soon as they park. Loitering in the parking lot will not be permitted. Cars should not be used as lockers. Students should return to their cars ONLY when leaving school at the end of the day, at lunch (Seniors and designated Juniors Only), or after checking out through the proper procedures. Administrative permission must be acquired in order to enter the parking lot during the day.
2. Once you have driven into the student parking lot in the morning, you may not leave campus without properly checking out through the appropriate checkout procedures. Penalty will be revocation of your AHS Parking hang tag.
3. AHS Parking hang tags, once issued, may not be altered. AHS Parking hang tags must be displayed on your REARVIEW MIRROR.
4. It is the responsibility of a student to know the grade level of his/her passengers. REMEMBER-LEAVING CAMPUS FOR LUNCH IS A PRIVILEGE.
5. Vehicles displaying words, graphics or designs, which in the opinion of the school Administration of Atlantic High School, deemed to be disruptive, are prohibited.
6. Students parked in an unauthorized area may have their AHS Parking hang tag taken and may be assessed a \$10.00 fine.
7. Cars parked without an AHS Parking hang tag on school grounds may be towed at owner's expense.
8. The Administration of Atlantic High School reserves the right to make any adjustments it deems necessary to enforce student parking regulations to ensure the safety and protection of the student population.
9. A PRINCIPAL OR DESIGNEE MAY SEARCH, INCLUDING BUT NOT LIMITED TO: A STUDENT'S PERSON, BRIEFCASE, BOOK BAG, PURSE, PACKAGES, LOCKERS, STORAGE AREAS AND VEHICLES, UPON REASONABLE SUSPICION OF PROHIBITED OR ILLEGALLY POSSESSED SUBSTANCES OR OBJECTS.
