- BCCHS Student and Parent/Guardian fill out the *Left* side of the form.
- Authorization for medical care must be signed on the back of the form by the <u>Guests</u> parent/guardian or it will be considered complete.
- If Guest attends High School, Guest's High School Administrator must sign on the *<u>Right</u>* side of the form. Attach a business card of the signing administrator.
- If Guest goes to College, Guest's Parent /Guardian must sign on the <u>*Right*</u> side of the form and Authorization for medical care on the back side of form.
- Guest <u>MUST</u> have ID with them at the dance, or they will not be allowed entrance to the dance.
- No Guest over the age of <u>20</u> or under the age of <u>14</u> will be allowed. If there are any questions regarding age, refer them to Mr. Navarro.

\*All guests must be between the ages of 14-20 and may not be a student at a junior high school.

\*\* If the student or guest is over 18, the student or guest must STILL obtain a parent/guardian signature. If you or your guest is over 18 and cannot obtain a signature, this line must be signed by a BCCHS administrator <u>before</u> you purchase your prom ticket in order for your agreement to be considered complete. It is the <u>student's</u> responsibility to obtain all signatures on this sheet.

BCCHS Administration reserve the right to refuse entry to any student or guest if in the best interest of the general student body.

### DANCES ARE A SCHOOL-SPONSORED ACTIVITY AND ALL SCHOOL RULES AND REGULATIONS WILL BE IN EFFECT.

In particular, your attention is called to the Birmingham Community Charter High School's policy on possession, use, and/or influence of alcohol, drugs or any controlled substances. Stated simply:

Any student who has unlawfully possessed, used, sold or otherwise furnished or been under the influence of any controlled substances as defined in Section 11032 of the Health and Safety Code, alcoholic beverage or intoxicant of any kind at school or any school-sponsored activity shall be subject to:

- 1. An immediate suspension;
- 2. Possible arrest by law enforcement authorities;
- 3. Possible expulsion from BCCHS;
- 4. Possible denial of the privilege of participating in graduation ceremonies and/or extracurricular activities.

Security officers will monitor activity throughout the evening. You are further advised that any such violation of the above policy will necessitate the student's parent providing transportation home from prom and the ticket money will not be refunded. By signing this agreement students & parents agree to possible random screenings for drugs and alcohol. Refusal to take a breathalyzer test or a drug test will be considered an admission of guilt, and students will be sent home without a refund.

Students whose guests are not BCCHS students must have their guest approved. Administration will screen the list of all guests. If your guest is not eligible to attend, you will be asked to choose another. **Dance tickets are non-transferable**. If there are any changes to your guest after approval is received or if a guest is added to a single ticket for any reason a <u>\$15 fee</u> will be charged. Refunds will not be given out after October 7<sup>th</sup>., 2022 due to fixed costs. By signing this form students and parents agree to all of the rules in this four-page prom packet.

### **REQUIRED DRESS CODE:**

The dance dress code will be enforced. Appropriate dress for a school dance is required and is expected for the entire evening. IF YOU ARE DRESSED INAPPROPRIATELY, YOU WILL NOT BE ALLOWED TO ENTER THE DANCE AND YOUR MONEY WILL NOT BE REFUNDED. Students must remain dressed as they entered throughout the dance. BCCHS administration retains the authority to ban specific clothing to maintain event safety. If you have questions regarding dance attire, please contact the ASB Office.

### **BEHAVIOR & DANCE FLOOR EXPECTATIONS:**

Students and their guests are expected to behave appropriately. Any students or guests who engage in dangerous, lewd or other inappropriate behavior, including any dancing that may be interpreted as being sexually suggestive, as determined by school personnel, will be removed from prom which will necessitate parents providing transportation home from the venue and your ticket money will not be refunded. Students also risk the denial of the privilege of participating in graduation ceremonies and/or extracurricular activities.

### VOLUNTARY ACTIVITIES PARTICIPATION

I understand and acknowledge that participation in these activities, by their very nature, pose the potential risk of serious injury/illness to individuals who participate in such activities. I understand and acknowledge that participation in these activities is completely voluntary and as such is not required by the school for course credit or for completion of graduation requirements. I understand and acknowledge that in order to participate in these activities, my son/daughter and I agree to assume liability and responsibility for any and all potential risks that may be associated with participation in such activities. I understand, acknowledge, and agree that the school, its employees, officers, agents, or volunteers shall not be liable for any injury/illness suffered by my son/daughter which is incident to and/or associated with preparing for and/or participating in these activities.

### **AUTHORIZATION FOR MEDICAL CARE:**

Should it be necessary for my son/daughter to have medical care while participating in this trip. I hereby give the school district personnel permission to use their judgment in obtaining medical care and ambulance service. I also give permission to the physician selected by the school district personnel to render medical care deemed necessary and appropriate by the physician. I understand that the school district has no insurance covering such medical or hospital costs incurred for such medical or hospital costs incurred by my child and therefore, any cost incurred for such treatment shall be my sole responsibility.
