# School Plan for Shared Student Achievement



### ●What is it?

Turner County Elementary School is committed to the goal of providing quality education for all of its students. In order to reach this goal, we believe partnerships should be established with the home and community. It shall be the intent of all parental involvement activities to encourage and support the efforts of the home, school, and community in improving the educational opportunities of all children. This plan will describe the different ways that Turner County Elementary will support parent engagement and how parents can help plan and participate in activities and events to promote student learning at home.

### ●How is it developed and revised?

Turner County Elementary School will invite all parents to attend our Parent and Family Engagement planning meeting to review and revise this Parent and Family Engagement Plan, as well as the school-wide plan, our school-parent compact and the parental involvement budget. The plan will be posted on our school website for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey in the Spring to ask parents for their suggestions on the plan and the use of funds for parental involvement. Parents can also give feedback during several parent meetings and activities during the school year.

### ●Who is it for?

All students participating in the Title I, Part A program, and their families, are encouraged and invited to fully participate in the opportunities described in this plan. TCES will provide full opportunity for the participation of parents with limited English, parents with disabilities and parents of migratory children.

### ●Where is it available?

The plan will be sent home to parents and also posted on the school website. Parents can also receive a copy of the plan in the front office or from the Parent and Family Engagement Resource Center located in Room 047 at TCES.

## What is Title I?

Turner County Elementary is identified as a Title I school as required by the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards in reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement.
