

**NOTICE TO TAXPAYERS AND ALL OTHER PERSONS AFFECTED OF PUBLIC
HEARINGS OF SILVER CREEK SCHOOL CORPORATION CONCERNING A
PRELIMINARY DETERMINATION TO ENTER INTO A LEASE WITH RESPECT TO
A SCHOOL CONSTRUCTION PROJECT**

Notice is hereby given to taxpayers and all other persons affected thereby that two public hearings for the project described below will be held before the Board of School Trustees of Silver Creek School Corporation (the “Board” and the “School Corporation,” respectively) on the dates, times and at the locations described below upon a resolution (the “Resolution”) preliminarily determining to obtain financing on the school construction project described below through a lease with a school building corporation incorporated under Indiana Code 20-47-3. Following the public hearings, the Board will consider for adoption the Resolution. The proposed school construction project is described as follows:

The Project consists of the planning, designing and construction of improvements to (i) the Silver Creek High School, including but not limited to the addition of classrooms, science labs, auditorium music/art suite, computer graphics studio, flexible learning space, media center, kitchen prep area, cafeteria dining, circulation, walls and related improvements; general renovations and main gym renovations, radio/TV broadcast center, music production studio, fieldhouse/outdoor improvements such as athletic facility improvements, new transportation service building, new central office administration building, moving transportation, new storage building, parking paving, fencing, sidewalk improvements, parking area expansion, furniture and equipment in connection with the improvements (e.g., seating, desks, tables), and all related improvements in connection therewith; (ii) the Silver Creek Middle School, including but not limited to the addition of classrooms, classroom equipment, window and floor replacement, and all related improvements in connection therewith; (iii) the Silver Creek Elementary School including but not limited to the playground, landscaping, window replacement, wall covering improvements, moving transportation, and all related improvements; (iv) the Silver Creek Primary School, including but not limited to the addition of classrooms, equipment and landscaping; and (v) the Sellersburg Elementary building, including general building updates throughout the entire building, and all related improvements (collectively, the “Project”).

The two separate public hearings with respect to the proposed Resolution will be held on March 1, 2022 at 6:30 p.m. (first hearing) and on March 8, 2022 at 6:30 p.m. (second hearing). Both of the public hearings will be held at the Silver Creek Primary School, 8604 Commerce Park Drive, Sellersburg, Indiana 47172. The public hearings will be held in accordance with Indiana Code 6-1.1-20-3.5 and 20-26-7-37 and will address the proposed Resolution which makes a preliminary determination in respect of the lease financing of the Project.

At each of the hearings described herein, all persons interested shall have a right to be heard with respect any matters pertaining to the Board’s consideration of adopting the Resolution.
