

**OLDHAM COUNTY BOARD OF EDUCATION  
MEETING MINUTES  
SEPTEMBER 6, 2022**

**TAX HEARING**

The Oldham County Board of Education met in Special Called session at the Arvin Education Center in La Grange, KY, on Tuesday, September 6, 2022, with the following members present: Joyce Fletcher, Board Chairperson; Larry Dodson, Board Vice Chair; Patrick Kehoe, Board Member; Suzanne Hundley, Board Member; Andrea Neikirk, Board Member, and Jason Radford, Superintendent and Secretary to the Board.

**1. MEETING CALLED TO ORDER**

Chairperson Fletcher called the meeting of the Oldham County Board of Education to order at 6:02 p.m.

**2. AGENDA APPROVAL**

With no changes to the agenda, chairperson Fletcher, called for a motion and a second to approve. On a motion by Suzanne Hundley, seconded by Larry Dodson, and unanimously carried, the Board approved the September 6, 2022, special called board meeting agenda. (5-0).

**3. SUPERINTENDENT REPORTS**

Finance Officer, Stephanie Anderson presented a report of Available Property Tax Rates for FY23 (July 1, 2022 – June 30, 2023). Question and Discussion from the board members followed the report. The Board took the report under advisement.

**4. MONTHLY PUBLIC EXPRESSION**

Chairperson Fletcher stated it was time for public expression and called upon the public expression registrar Michael Williams for the registered speakers. 10 people had registered to speak. Chairperson Fletcher asked Larry Dodson to read the rules for addressing the board. **5. ACTION ITEM**

After Public Expression, the following action was taken.

A. Approval of Property Tax Rates for FY23 (July 1, 2022 – June 30, 2023).

Chairperson Fletcher called for a motion to adopt the Superintendent's recommendation for FY23 tax rates. On a motion by Andrea Neikirk, seconded by Larry Dodson, the Board approved the FY23 tax rates as follows. (3,2) Suzanne Hundley opposed. Patrick Kehoe opposed.

- 1) Adopt the tax rate of 81.2 cents per \$100 assessed value for both Real Property and Tangible Personal Property with the allocation of such tax rate being:

General Fund	58.8
Building Fund	22.4

- 2) Motor Vehicle Tax Rate of 64.3 cents per \$100 of assessed value
- 3) Utility Tax Rate of 3.0%

6. **ADJOURN**

Chairperson Fletcher, acting on the Superintendent's recommendation to adjourn, called for a motion and a second to adjourn. On a motion by Patrick Kehoe, seconded by Andrea Neikirk, and unanimously carried, the Board adjourned the September 6, 2022, meeting at 7:01 p.m. (5-0).
