

**OLDHAM COUNTY BOARD OF EDUCATION

September 12, 2022**

The Oldham County Board of Education met in a Special Called work session at LaGrange Elementary School, on Monday, **September 12, 2022**, with the following members present: Joyce Fletcher, Board Chairperson; Larry Dodson, Board Vice Chair; Patrick Kehoe, Board Member; Suzanne Hundley, Board Member; Andrea Neikirk, Board Member; and Jason Radford, Superintendent and Secretary to the Board.

**1. MEETING CALLED TO ORDER**

Chairperson Fletcher called the meeting of the Oldham County Board of Education to order at 4:30 p.m.
