

**OLDHAM COUNTY BOARD OF EDUCATION
MEETING MINUTES
August 29, 2022**

The Oldham County Board of Education met in regular session at the Arvin Center, on Monday, August 29, 2022, with the following members present: Joyce Fletcher, Board Chairperson; Larry Dodson, Board Vice Chair; Patrick Kehoe, Board Member; Andrea Neikirk, Board Member and Jason Radford, Superintendent and Secretary to the Board.

The meeting was held in person and recorded.

1. MEETING CALLED TO ORDER

Chairperson Fletcher called the meeting of the Oldham County Board of Education to order at 4:32 p.m.

2. AGENDA APPROVAL


The Board returned from executive session at 7:51 p.m. There was no action taken coming out of executive session.
