Ryan Bush a parent of a middle school student addressed the board. Her family members were long term administrators in other school districts. She mentioned the difficulty of being a parent of a middle school student. She thought that Denny handled the job with humility, passion, and courage.

Following public participation President Arthur read the following statement:

“Denny Morrison was hired as Middle School Principal two years ago, in what was intended to be a one-year interim assignment. It was extended to two years by mutual agreement of Mr. Morrison and the Board. Mr. Morrison’s contributions toward improving the culture at the Middle School have been greatly appreciated. He has increased communication, collaboration, and engagement with our students, families, and community. He was an excellent choice to serve as an interim principal and this decision to move forward with a long-term replacement is not based on Mr. Morrison’s performance.

We began this process two years ago in search of a long-term principal to replace Mrs. Minear following her retirement. We have communicated to Mr. Morrison that our priority to find a long-term replacement remains and we no longer wish to fill this position on a year-to-year basis. Mr. Morrison has agreed with that decision and expressed his desire to be considered for a long-term position. It is our consistent practice that long-term administrative contracts should not be issued without a thorough interview process. If Mr. Morrison is interested in the position on more than an interim basis, then he will be given full consideration.

Our District has begun a search for a principal to implement and oversee our curriculum and instruction initiatives over the period of the next few years. A leadership change at this time allows the new principal to establish a vision for the building and lead these initiatives from the beginning of this process. Improvement initiatives take time and long-term consistency in the principal position is our priority as we move forward. Our application window closes tomorrow and Mr. Seevers and the administrative team will begin interviews next week.

We would like to publicly thank Mr. Morrison for his leadership the past two years as our interim Middle School Principal.”
