

Memorandum of Understanding
by and between
Renton School District
And
Renton Education Support Professionals
Regarding Fundamental Course of Study (FCS)

Based on legislative changes during the 2022 Washington legislative session, the parties agree to the following modifications to the 2021-2023 collective bargaining agreement:

3.6 Paraeducators Requirement re: Fundamental Course of Study and General Paraeducator Certificate (GPC)

If funded by the legislature, the District will offer twenty-eight (28) hours of training per work year to each employee for FCS and fourteen (14) hours of training per work year to each employee for GPC. Training hours qualifying for completion of FCS and GPC may overlap. Employees shall be paid at the time and one-half rate for FCS courses 01, 05, 06, 07, 09, and 12 courses. Employees shall be paid at their regular rate of pay for all other FCS courses and requirements for the GPC. Employees working on their GPC may choose which of the trainings to apply to the fourteen (14) hours, provided that the trainings qualify as hours applicable to the GPC curriculum adopted by the State Legislature.
