

Venues for movies and live performances may open to the general public at 50% capacity, or 100 people per auditorium (if indoors) or 250 people (if outdoors)—whichever is less.




Retail stores may expand operations from 50% to 75% capacity with strong physical distancing, masking, and other safety precautions in place.




Religious facilities may increase capacity from 50% to 75%. Distancing, masking, and safety protocols are strongly advised to keep congregants safe.




## **Testing Positivity Rate**








# **State Superintendent Salmon**


St. Mary's County Public Schools was one of the 16 districts in MD recognized for meeting this first quarter return target.

- The SMCPS Safe Return Plan provides a process for reviewing data, changing public health conditions, and implementation experience.
- Throughout the first quarter, this information will be reviewed to phase in students for returning starting with a hybrid learning model.




# Schoology Access: Elementary Schools






85.0% of all enrolled elementary students have logged into Schoology and are engaging with their teachers and peers

# **Schoology Access: Secondary Schools**




**92.9%** of all enrolled middle school students have logged into Schoology and are engaging with their teachers and peers

# **One to One and Connectivity**

- Significant progress has been made throughout the summer
- New Devices working toward 1:1

#### SMCPS purchased over 9,000 devices in the past 4 months

- Many of those devices have arrived- others on the way!
- Some are slightly delayed due to high demand for mobile technology across the country and world.
- First phase of technology distribution targeted to students without a device
  - As of 8/28/2020, 6,013 devices had been delivered to schools for distribution to students
  - Of the devices issued to students, about 4,487 (75%) were successfully set up <u>by</u>
     <u>noon on the first day</u> of school (August 31)

### **Internet Connectivity**

#### **Broadband Grant**

- Hotspots: SMCPS staff will be in touch with families to distribute hotspots

#### Comcast/Atlantic Broadband (essential services/low cost plans)

- Atlantic Broadband (<u>Internet Assist</u>)
  - Offering basic internet speed tier to those who live in their serviceable area, do not currently have Atlantic Broadband internet service in their home, and meet specific need-based qualifications.
- Comcast (<u>Internet Essentials</u>)
  - Need-based qualifications to be eligible for the Internet Essentials program.
  - New Internet Essentials customers will receive two free months of Internet service if they enroll in the program by December 31, 2020.

# ATLANTIC BROADBAND INTERNET ASSIST PROGRAM

#### What is the Atlantic Broadband Internet Assist program?

In direct response to the COVID-19 situation and the increased need to connect to work and/or school from home, Atlantic Broadband is offering a 15 Mbps downstream / 1 Mbps upstream internet speed tier to those who live in Atlantic Broadband's serviceable area, do not currently have Atlantic Broadband internet service in their home, and meet specific need-based qualifications.

#### How much does the Atlantic Broadband Internet Assist program cost?

The program offer is for \$9.99 per month plus tax.

#### What do I need to do to qualify for the Atlantic Broadband Internet Assist program?

The Atlantic Broadband Internet Assist program has been designed to provide internet access to in-need households that meet all of the following qualifications: Those who 1) do not currently subscribe to an Atlantic Broadband Internet Service and who have not subscribed to Atlantic Broadband Internet Service in the last one hundred and twenty (120) days; 2) do not have any past due balances with Atlantic Broadband; 3) have not been disconnected from any Atlantic Broadband service within the last twelve (12) months due to non-payment; and 4) are eligible for any of the following public assistance programs: National School Lunch Program (NSLP), Housing Assistance, Medicaid, Supplemental Nutrition Assistance Program (SNAP), Low Income Home Energy Assistance Program (LIHEAP), and/or Special Supplemental Nutrition Program for Women, Infants and Children (WIC). Customers will be required to provide proof of eligibility subject to the review and discretion of Atlantic Broadband.



# **Special Education**

#### How will IEP services be incorporated into the daily schedule?

 Special education teachers will collaborate with general education teachers to establish a schedule that provides all students access to the general education curriculum. An intervention schedule will then be established to provide services written in the student's Individualized Education Program (IEP).



As a result of waiver extensions from USDA, beginning September 9, 2020, breakfast and lunch pick-up service will be offered to all children 18 years of age and under free of charge.
