



# **Attendance Matters**





#### **ATTENDANCE**

Every child who resides in St. Mary's County and is 5 or older and under 18 must attend school regularly

## Regular Attendance

- Academic success
- Participation
- Greater understanding

# Unlawful or Excessive Absences

- Poor/failing grades
- Retention
- Ineligible for activities

# WHAT IS A LAWFUL ABSENCE?



- Death in the immediate family
- Student illness (a physician's note may be required)
- Pregnant and parenting student
- Court summons
- Hazardous weather conditions
- Work (approved or sponsored by the school)

- Observance of a religious holiday
- State of emergency
- Suspension
- Lack of authorized transportation
- Other emergencies or circumstances as determined by the principal

## **UNLAWFUL ABSENCES**



Absences for any reason other than those listed as lawful.

Family vacation absences are unlawful (exceptional circumstances may be reviewed by the principal/designee).

## MAKE-UP WORK



If you are absent from school, you should request make-up work.

#### **Lawful Absence**

- may receive full credit
- allowed to make up assignments, take alternative exams and tests
- five (5) school days to turn in completed assignments

#### **Unlawful Absence**

 may forfeit the opportunity to earn credit

# ALL ABSENCES MUST BE DOCUMENTED WITH A REASON

Parent(s)/Legal Guardian(s) can notify the school by-

- phone
- email
- school website portal
- written note

No documentation within three (3) days=UNLAWFUL

# **EXCESSIVE ABSENCES**



## If you are absent 25 days or more...

Responses may include:

- referral to the Pupil Services Team (PST)
- retention for the following year
- withholding credit for opportunity to learn and master grade level skills and/or course content

# **Tardy for School**



Present documentation stating reason for tardiness or have your parent(s)/legal guardian(s) sign you in.



Tardies are marked either lawful or unlawful.

Missing the bus or running late is marked UNLAWFUL.

# **DON'T FEEL WELL?**

Tell your mom, dad, or caregiver before you come to school. Tell your teacher or an adult if you become sick at school



# Do You Require Medication at School?



Your parent/legal guardian must:

- provide Medication Authorization Form (<u>PS 109</u>) completed by physician and signed by physician and parent
- give form (<u>PS 109</u>) and medication in original pharmacy container to nurse
- immediately notify school nurse of any medication changes
- pick up unused or discontinued medication from the school nurse

Students must NEVER bring medication to school (this includes over-the-counter medication such as Tylenol, aspirin, etc.)

# Are you eligible to play sports?



Grade Point Average (GPA) of 2.0 or above is required

YOUR MARKING PERIOD GRADES determine your GPA

Every marking period, you can become eligible or ineligible

#### CAUTION

You may be **INELIGIBLE** for high school activities **IF you are**:

- Suspended from school
- S assigned in-school intervention
- O debts and fines at the end of the marking period
- S absent from school

# What Are You Wearing?



Students are expected to follow the SMCPS Student Dress Code.



Dress or grooming which is likely to cause the disruption of the instructional program or which creates a potential safety hazard is prohibited.

# SCHOOLS ARE DRUG-FREE ZONES



SMCPS prohibits the possession, and/or use of illegal substances on school grounds.

Canine drug scans may be used to scan buildings and school grounds to protect and further ensure the safety of students.



Are you in a situation and need help? Talk to the school nurse, teacher, school counselor, social worker or administrator to get resources.

#### TOBACCO-FREE SCHOOL ENVIRONMENT



- no selling or use of tobacco or tobacco products/devices in any form
- prohibited in school buildings, on school grounds, on school buses and in vehicles

# No VAPE Zone



**Vaping May Cause Serious Health Risks/Consequences** 

E-cigarette aerosol is NOT harmless "water vapor".

E-cigarette vapor can contain harmful and potentially harmful substances:

- Nicotine
- Ultrafine particles that can be inhaled deep into the lungs
- Flavoring such as diacetyl, a chemical linked to a serious lung disease
- Cancer-causing chemicals
- Heavy metals such as nickel, tin, and lead

# No VAPE Zone



#### Why Is Nicotine Unsafe for Kids, Teens, and Young Adults?

- can harm brain development
- can harm parts of the brain that control attention, learning, mood, and impulse control
- may increase risk for future addiction to other drugs

# **Know the Consequences**

204 - Tobacco or Tobacco Products

Possession, use, sale, or distribution of tobacco, tobacco products, and/or devices (e.g., cigarette lighters, <u>e-cigarettes</u>, vaporizers, and matches).

#### Level 1-3

Using/possession tobacco/e-cigarettes. First time offense.

#### Level 4

Repeated use/possession of tobacco/e-cigarettes.

#### <u>Level 1-4</u>

Distribution



Reporting to law enforcement is required.

# **Inappropriate Use of Personal Electronics**

Code 802- Unauthorized or inappropriate use of any electronic device carried, worn, or transported by a student on school property to receive or communicate messages.

 Devices include, but not limited to mobile phones (smartphones and traditional cellphones), tablets, wireless audio devices (wireless earbuds, headsets, and speakers) and wearable technology (smartwatches and fitness trackers).

#### Level 1-4

Unauthorized or inappropriate use of any electronic device.

#### Level 4-5

Unauthorized use to include photographing, recording, sharing, and/or publishing inappropriate pictures, videos, or recordings, including fights or other disturbances.

- may be confiscated by an administrator for inappropriate use
- parent/legal guardian may be required to meet with an administrator
- school assumes no liability for lost, stolen, or broken devices



#### Using Your Phone During Restricted Times?

- <u>In classrooms</u>: Administrator/designee will direct student to turn off phone, phone will be stored in secure location in the administrative office.
- <u>In hallways</u>: Administrator/designee can confiscate phone and store in secure location in the administrative office.



## **School Issued Electronic Devices**




- Illegal activity

- Access to obscene or pornographic material



## Student Handbook/Code of Conduct Updates

#### Student Dress Code

#### **Changes are in Red**





- Clothing displaying or suggesting profanity; sexual activity through graphic images, words, or innuendos; weapons; drugs/alcohol or drug paraphernalia; violence; or tobacco products may not be worn, visible or displayed.
- Clothing with identifiable gang/crew representation or paraphernalia may not be worn, visible, or displayed.
- Symbols or messages generally accepted to promote intolerance, hate, racial slurs (for example Confederate flag, swastika, Ku Klux Klan or KKK) may not be worn, visible, or displayed.
- Head coverings may only be worn indoors so long as the student's face is visible and it does not interfere with instruction or student safety. Ski masks may not be worn indoors.
- Shoes must be worn that are safe for all activities.
- Official St. Mary's County Public Schools' athletic uniforms may be allowed at the discretion of the coach and school administrator.
- Student dress for school-sponsored activities must be in compliance with the Student Dress Code.



# Student Handbook/Code of Conduct Updates



#### **Telehealth Services**

Telehealth aims to enhance student health and well-being by increasing access to various healthcare services within the school environment, such as primary and specialty care, as well as behavioral health services while minimizing the loss of instructional time.

- Now offering confidential space for telehealth appointments for students at each high school, one day per week during the designated "One Lunch" period.
- Families must arrange and coordinate these appointments in advance with their high school and healthcare provider.
- Parent(s)/legal guardian(s) must sign their student out of school and remain with their student for the duration of the appointment.
- Families are responsible for bringing their own device to connect with their personal healthcare provider.

# 806 - Destruction of School/Bus Property

# XX

#### **Changes are in Red**

Damage, destruction, or defacement of property belonging to the school or others.

Restitution is to be made. The restitution may be in the form of monetary restitution not to exceed the lesser of the fair market value of the property or \$2,500.00 or the student's assignment to a school work project, or both. (Maryland Law § 7-305(h) and COMAR 13A.08.01.11.D)

- Schools should consider the following factors:
  - the monetary value of the destroyed property
  - whether student knew the property was valuable or expensive to replace
  - o whether student acted in the heat of the moment, as opposed to planning ahead
  - the student's age
  - the reason student destroyed the property
  - o whether the behavior is persistent/habitual.
- Apply extended suspension and expulsion only to grades 6-12
- Level 5: If the school administrator decides to request an expulsion conference, the school administrator or designee must contact the Department of Student Services within two (2) days of the alleged offense to

# 806 - Destruction of School/Bus Property

#### Level 1

Causing accidental damage.

#### Level 1-3

Intentionally causing damage to school/other's property.

#### Level 2-5

Intentionally causing damage to school/other's property, where the act is especially serious based on the listed factors.



# 701- Disrespect



#### Changes are in Red

Making inappropriate or offensive gestures, symbols, and/or comments to teachers, staff members, or others in any format (written, verbal, and/or electronic).

- Apply extended suspension and expulsion only to grades 6-12.
- Level 5: If the school administrator decides to request an expulsion conference, the school administrator or designee must contact the Department of Student Services within two (2) days of the alleged offense to request an expulsion conference.

#### Level 1-2

Making intentional and harmful gestures, verbal or written comments, or symbols to others (e.g., verbal put-downs, cursing, talking back)

#### **Level 2-45**

Being insubordinate: repeatedly or persistently disrespectful, in defiance of authority.

## Gang Activity/Disruptive Behavior



- gang activity/illegal group behavior/similar destructive behaviors
- retaliation against those who report behavior

#### Consider this...

- this behavior is reported to the police.
- report this behavior to an adult at the school by using the "Gang-Related Incident Reporting Form."

## **Fighting**



 A physical confrontation involving two (2) or more students.

#### Consider this...

- fighting leads to suspension
- this behavior may be reported to the police

## **Bullying**

 Intentional unwanted, demeaning behavior among students (written, verbal, electronic, or physical gestures) that involves a real or perceived power imbalance



# Bullying



- Must be intentional
- Students who bully use their physical, emotional, social, or academic power to control, exclude, or harm others
- Bullying behaviors happen more than once or are highly likely to be repeated based on evidence gathered

## **Sexual Harassment**

- Unwanted sexual attention from students, teachers, or other adults
- It may occur once or be repeated over time

An adult needs to know so that corrective action can be taken.

#### Say NO

REPORT it to an adult (school counselor, teacher, parent(s)/legal guardian(s), administrator, or the Title IX designee).

# Bullying/Harassment~Need Help?

SAY SOMETHING- Report this behavior to an adult such as your school counselor, teacher, administrator, or parent(s)/legal guardian(s)

An adult will take appropriate action

Also complete:

Bullying, Harassment, & Intimidation Reporting Form (Online)

Bullying, Harassment, Intimidation Reporting Form (Print)

Bullying, Harassment, Intimidation Form (Spanish version)

Forms are also available in the school main office

## **Sexual Assault**

- unwelcome sexual contact, either directly or through clothing
- committed by threat or by force
- without consent of the other person
- behaviors may include deliberate inappropriate touching/pinching/grabbing of a sexual nature, attempted rape, or rape

SAY SOMETHING- Report this behavior to an adult such as your school counselor, teacher, administrator, Title IX designee, or parent(s)/legal guardian(s)

An adult will take appropriate action.

## **WEAPONS**



- You will be reported to the police and the superintendent of schools or his/her designee immediately
- The Gun Free School Act of 1994 and other public laws require expulsion from school for a period of not less than one calendar year

Principal or Assistant Principal has **reasonable belief** that in your possession is an item that is in violation of any federal or state law, or violation of a SMCPS rule or regulation.

The school building, furnishings, and lockers may be searched.
