- h. Authorize the Superintendent to employ certified and classified personnel.
- i. Authorize the Superintendent to accept resignations of certified and classified personnel.

- j. Appoint the Treasurer as the Public Records Officer for a two-year period beginning January 1, 2021, and ending December 31, 2023, and designated to receive the public records training on elected official's behalf.
- k. Appoint Purchasing Agent - that the Superintendent be appointed Purchasing Agent for the Greeneview Local School District for the calendar year 2021.
- l. Appoint Title IX Compliance Officer – that the Superintendent be appointed Title IX Compliance Officer for the Greeneview Local School District for calendar year 2021.
- m. Authorize the Superintendent to approve all staff absences and/or leaves, unless negotiated agreements indicate differently. (ex. - Personal Leave by principals-G.E.A. contract).
- n. Board designates its Superintendent to be the Board's designee for purposes of hearing final student suspension appeals.
