Dear Parent or Guardian:

We are pleased to inform you that Ansonia Public Schools will continue to implement programs available to schools participating in the National School Lunch Program and School Breakfast Programs called the **Community Eligibility Provision (CEP)**.

What does this mean for you and your children attending the school(s) identified below?

Great news! All enrolled students of Ansonia Public Schools are eligible to receive a healthy breakfast and lunch at school at **no cost** to your household each day of the school year. Your child(ren) will be able to participate in these meal programs without having to pay a fee or submit a meal application.

- You do not need to do anything.
- You do not need to pay any money
- You do not need to fill out any forms
- You do not need to send your child to school early to participate in breakfast, it is served as part of the school day.
