**DEED OF VARIATION
relating to a Supplemental Funding Agreement
dated 1st February 2018**

THIS DEED OF VARIATION is made on

2020

BETWEEN:

- (1) The Secretary of State for Education ("**Secretary of State**"); and
- (2) Stowe Valley Multi Academy Trust, a charitable company incorporated in England and Wales with registered number 10445759 ("**Company**")

together referred to as the "Parties".

INTRODUCTION:

- (A) The Parties entered into a Supplemental Funding Agreement dated 1st February 2018 ("**the Funding Agreement**") relating to the establishment, maintenance and funding of an academy known as Stockton Primary School.
- (B) The Parties now wish to vary and amend the terms of the Supplemental Funding Agreement and wish to record their agreement as to such variations/amendments to the Funding Agreements by this Deed.

IT IS AGREED as follows:

1. The Secretary of State and the Company agree that with effect from the date of this Deed the Funding Agreements shall be amended and restated in the form set out at Schedule 1 to this Deed.
2. As varied by this Deed, the Funding Agreements shall remain in full force and effect.
3. This Deed, and any disputes or claims arising out of or in connection with it, its subject matter of formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.
4. The parties irrevocable agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

5. This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.

This document has been executed and delivered as a Deed on the date stated at the beginning of this Deed.




