We are pleased to inform you that NEW PARADIGM GLAZER ACADEMY will be participating in the Community Eligibility Provision (CEP) as part of the National School Lunch and School Breakfast Programs for the School Year 2022-2023.

The GREAT NEWS is that ALL students enrolled at our school can receive a healthy breakfast and lunch at NO CHARGE to your household each day.

Students will also qualify for FREE internet service for completing the household information form. A letter will be sent to each household with a completed form for notifying the service provider that you are eligible to receive free internet.

In place of the Free and Reduced-Price Meal Application we still need your household to **fill out and sign the Household Information Report**. In order for ALL students to receive free breakfast, free lunch and free internet we are required to have this form on file for ALL students. We will provide each household with a letter to submit to the internet provider for free service.

We are asking that you please complete and submit it by September 30th. Failure to obtain completed forms can jeopardize our ability to offer FREE breakfast and lunch for ALL students.

HOUSHOLD INFORMATION REPORT

This report is used to determine eligibility for state benefits for which your child(ren)'s school may qualify. Please complete, sign, and return this form to your child's school.
