ix. **12 ESSER: Improving Equity in CTE**

The Ephrata School District was recently awarded \$33,000 from OSPI for Form Package 12: ESSER: Improving Equity in CTE. Sarah Vasquez, CTE Director and Scott Sandberg, High School CTE Coordinator, wrote the grant jointly. Through the utilization of this grant, CTE will expand to provide equitable and inclusive experiences in classes that are historically underrepresented with technological, and hands-on learning. This grant will allow students to accelerate their learning through various modalities. This grant will be used to amplify and transform learning and teaching experiences and supports with the goal to empower learners by providing equitable opportunities including courses that provide equivalency credits in math, science and art. To support equity in CTE, grant funds will be used on professional development for staff, including the National CTE Conference in November.

b. Approve Google Workspace for Education Purchase

The technology department is considering upgrading the Google Workspace for Education from a free version to Google Workspace for Education Plus. The price is an annual estimated \$14,000 (\$5 per student). This cost includes teacher licenses. The upgraded platform will provide students, teachers and staff with increased features including the chromebook security, device management enhancements and direct integration between the Google Classroom gradebook and Skyward. The included security center will enable the technology department to better respond to phishing, malware and other cybersecurity threats.
