


### **Survey Summary**


- The survey was conducted in late May early June of 2018.




## Is your primary residence in the Elkhart Lake-Glenbeulah School District?






# Do you have child(ren) attending school in the Elkhart Lake-Glenbeulah School District?




## If you have school-aged children, what school(s) do they attend?







### **Operational Referendum**

(Elkhart Lake-Glenbeulah School District Taxpayers Only)

In 2015, the community generously supported the Elkhart Lake-Glenbeulah School District with a four-year operating referendum. The goal of these funds was to allow the District to maintain the quality services and programs our community has come to expect and replace the aged heating and ventilation system (HVAC) at the elementary and high school buildings.

Due to careful planning, the District was also able to utilize these funds to complete other facility projects, including:

- Update and add exterior lighting to buildings, parking lots
- Add secure entrances to the high school and daycare
- Installation of solar panels at the high school (for educational purposes and to power the Fitness Center)
- Resurface tennis courts and parking lots
- Update lighting, generator and communication systems
- Install additional security cameras through the District
- Update technology infrastructure
- Update bathrooms in child care, elementary and high school
- Replace fixtures, plumbing and tile flooring
- Replace inefficient windows and doors
- Address Americans with Disabilities Act (ADA) code compliance issues
- Purchase an additional van for student/staff transportation

In addition, we have allocated funds to complete phase 2 of the HVAC replacement project. There are 6 units still in need of replacement, and these units will be replaced as they fail.

#### **Operating Funding Support**

Due to changes in student enrollment, over the next six years, the District will receive \$600,000 to \$900,000 less funding annually. In addition, the 2015 referendum which provided \$725,000 annually will end. As a result, beginning in 2020 the District is forecasting a budget shortfall ranging from approximately \$1.18 to \$1.61 million for each of the following 5 years. The District is proposing a new referendum to address this shortfall while maintaining the current (2018) tax mill rate of \$7.91.

If voters <u>do not support</u> the proposed referendum, the District will need to make significant cuts to programs and services and delay technology replacement and maintenance projects in order to balance the budget.


If voters <u>support</u> the proposed referendum, the District would be able to maintain current programs and services as well as address technology and maintenance needs.



#### All Taxpayers





Staff Taxpayers






#### **Update Lighting and Bleachers at Football/Soccer Fields**


### **Update Auditorium**


### Renovate Culinary Arts Classroom and Lab


