

POSITION DESCRIPTION

TITLE: HOME SCHOOL CONTACT (Migrant On-Track Specialist)

TYPE: Classified

REPORTS TO: Director of Instructional Services

POSITION SUMMARY:

Under the direction of the Building Administrator, Instructional Services Coordinators, or the Director of Instructional Services, the Home School Contact (Migrant On Track Specialist) shall foster community and home-school relations as the medium through which a student's response to and benefit from the school and its programs can be strengthened and improved. The Migrant on Track Specialist will act as an advisor, liaison, and facilitator for migrant students in order to help them complete high school and pursue post-secondary opportunities. Services will focus on the unique and supplemental needs of the mobile migrant student and will not supplant those activities conducted by other building staff such as counselors, teachers, and administrators.

MINIMUM QUALIFICATIONS:

1. High School Diploma or equivalent by OAR 581-37-030.
2. 18 years of age or older.
3. Possess linguistic and cultural expertise of the target group.
4. Possesses and maintains a valid Oregon Driver's License.

ESSENTIAL FUNCTIONS:

1. Communicates effectively and appropriately in both oral and written form.
2. Communicates effectively in Spanish or Russian (if assigned) in both oral and written form.
3. Understand and follow oral and written instructions.
4. Work a flex-time schedule.
5. Maintain confidentiality.
6. Knowledge of community resources available to families, students and schools.
7. Assist in recruiting/identifying eligible migrant students/families.
8. Knowledge of secondary school programs and graduation requirements.
9. Determines what agencies, service organizations, businesses, and industries in the community can provide supportive services that will assist the school in meeting the needs of migrant students/families.
10. Develops open lines of communication within the triad of school, community and migrant families.
11. Encourages parents/guardians to visit and to participate in school activities and committees.
12. Works with the students and their parents/guardians to encourage regular attendance and appropriate behaviors.
13. Assist College and Career Counselor/HS Counselors in identifying/serving migrant students/families.
14. Keeps well-informed of all services available to migrant students/families such as day care,

- preschool, post secondary education, health and welfare services, etc.
15. Maintains a daily log and provides the Director of Instructional Services and building administrator with copies of the log and monthly report of activities.
 16. Participates in in-service programs as assigned by the Director of Instructional Services or building administrator.
 17. Develops a working knowledge of the interpretation and application of relevant school law.
 18. Uses referral system in providing supportive services to target group.
 19. Maintains a high level of ethical behavior and confidentiality when dealing with student and staff information.
 20. Follows all safety rules and takes all reasonable precautions to provide a safe and secure working environment.
 21. Demonstrates support for District Core Values, District Mission, District Strategic Plan.
 22. Collaborates and confers with students, parents, colleagues, and community members in a harmonious and respectful manner.
 23. Assists parents and community members as needed.
 24. Demonstrates an awareness of and sensitivity to multicultural and multilingual values and environments.
 25. Complies with professional development activities as required by the District.
 26. Holds expectations for high performance of self and students.
 27. Demonstrates computer literacy and operates software programs as related to job responsibilities.
 28. Maintains accurate, complete, and confidential records as required by law and District policy and regulations.
 29. Maintains the integrity of confidential information relating to a student, family, colleague, or district patron, and uses or relays academic, social, or personal information only in the course of performing assigned responsibilities and in the best interest of the individuals involved.
 30. Follows all laws, District policies, rules, regulations, memos, announcements, and reasonable requests by proper authority.
 31. Maintains regular attendance at work and work activities, and is punctual in meeting deadlines, attending meetings, and following schedules.

OTHER REQUIRED:

1. Criminal Justice Fingerprint Clearance
2. The employee is expected to be dressed and groomed in a neat, clean, and appropriate professional manner for the assignment and work setting.
3. This position is performed primarily indoors in school buildings and offices, although some outdoor work or supervision may be required.
4. In cases in which the employee is required to travel between sites, the employee is responsible for his/her own travel and will be reimbursed for approval mileage.
5. Possible exposure to bodily fluids due to student or employee illness or injury.
6. May be required to obtain a First Aid and/or CPR Card or be a Designated First Aid Provider.
7. May be required to translate and/or interpret.
8. Occasionally performs other duties as required by supervisor.
