  - Social – Parent Facilitators, Communities in Schools, Social Worker, Clubs and Organizations
  - Emotional – Parent Facilitators, Communities in Schools, Social Worker, RTI/TMSS, SEL curriculum, Purple Door
  - Behavioral – RTI/MTSS, Warrior Academy, PAX
  - Clinical – Social Worker, TCHAT
- **Program Overview**
  - ASCD Framework for Whole Child Development (WCD) – Handout was discussed and reviewed.
  - Maslow’s Hierarchy of Student Needs – Handout was discussed and reviewed.
- **Parent and Family Engagement** – discussion of importance to increase participation and to focus on building parent capacity, particularly on vaping and mental health. Events for parents should focus on building capacity and increasing parent education and awareness of student health concerns (e.g., vaping, suicide).

- d. Presentation by Jordan Garza: Vaping and THC Curriculum. Ms. Garza presented over COADA CB curriculum to be used with HS students during Red Ribbon Week.  
Approved use of Coastal Bend Wellness Foundation and COADA CB curriculum to be used at the high school for Social and Emotional Learning and Safe and Healthy Schools.
