REDIRECT YOUR TAXES TO GAC IN SUPPORT OF CHRISTIAN EDUCATION

If you have income subject to Georgia income tax, our state's Education Expense Credit law provides an incredible opportunity to redirect a portion of your state income tax to Greater Atlanta Christian School. Your redirected tax dollars are utilized to provide needs-based scholarships for students who may otherwise not be able to attend Greater Atlanta Christian School. Enrollment in this tax credit program is simple and easy thanks to our partnership with Georgia GOAL Scholarship Program, a tax-exempt nonprofit organization recognized by the Georgia Department of Education as a qualified student scholarship organization under Georgia law.

When you redirect your state income tax to GAC, our school is able to:

- Increase needs-based financial aid for new students who otherwise could not afford the full GAC tuition
- Preserve existing financial aid to assist current families
- Increase funds available for educational & other offerings
- Further our mission by reaching more families desiring a Christian education
